Variance** permit to allow the expansion of a legal non-conforming use for the redevelopment of an existing senior living facility currently having 100 Assisted Living Facility beds and 276 skilled nursing beds and_ Conditional Use Permit (CUP) to allow a 276-bed skilled nursing facility with a distance separation of less 500 feet from single family homes and less than 1,200 feet from another existing similar facility. Properties located at **195 West 27th Street, 141 West 27th Street, 130, 140, 150 & 160 West 28th Street**, Hialeah, zoned R-3 (Multiple-Family District).

5. **Conditional Use Permit (CUP)** to allow a K-6th grade elementary school with a maximum capacity of 47-students in conjunction with a 36-children daycare. Property located at **380 West 21st Street**, Hialeah, zoned M-1 (Industrial District).

Item approved with the condition that the site improvements detailed in the plans prepared by Octavio Santurio, Architect, be permitted and the work finalized before August 2023 prior to the start of the school year. If this condition is not met, the BTR for the school should not be renewed in 2023.

6. **Special Use Permit (SUP)** to allow the expansion of the Neighborhood Business District Overlay for the development of a 58-unit multifamily mixed-use building. Variance permit to allow all residential units with areas ranging from 523 square feet to 728 square feet, where 850 square feet is the minimum required and only 10% of the units may have an area of 600 square feet; allow 5.5 feet front setback for staircase, where 10 feet built-to-line are required; allow 18% pervious area, where 30% is the minimum required and parking variance to allow 160 parking spaces, where 277 266 are required. Property located at **8155 West 12th Avenue**, Hialeah, zoned C-1 (Restricted Retail Commercial District).
