

**RESOLUTION NO. 2019-048**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA APPOINTING OBED SANTIESTABAN TO THE CITY OF HIALEAH CHARTER REVIEW COMMITTEE ("CRC") EFFECTIVE IMMEDIATELY FOR A TERM ENDING UPON THE DISSOLUTION OF THE CRC; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, Hialeah Charter § 8.01 provides that every tenth year following the effective date of the 1999 Hialeah Charter, the City Council shall appoint Hialeah resident electors as members to a Charter Review Committee to review the Hialeah Charter; and

**WHEREAS**, pursuant to Hialeah Charter § 8.01, the City Council shall also establish the membership, term, duties and responsibilities of the Charter Review Committee; and

**WHEREAS**, consistent with Hialeah Charter, the City Council desires to establish a Charter Review Committee to review its Charter and propose any amendments or revisions that may be advisable for placement on the upcoming election ballot on November 5, 2019; and

**WHEREAS**, the Charter Review Committee shall provide its Report and Recommendations to the City Clerk by July 2019 with recommended Charter Changes to be prepared in ordinance form for consideration by the City Council for first reading on or before August 13, 2019, with second reading on or before August 27, 2019, and upon acceptance or rejection of the proposed Charter Amendment Ordinance or Ordinances or revisions by the City Council and being directed by the City Council to do no further action, the Charter Review Committee shall be dissolved.




**Section 1:** The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.




