RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO ENTER INTO A SOFTWARE AS A SERVICE (SAAS) MASTER AGREEMENT WITH SIRSI CORPORATION, A COPY OF WHICH IS ATTACHED TO THIS RESOLUTION, FOR FIVE YEARS, COMMENCING ON THE DATE THE LAST PARTY SIGNS, WITH SUBSEQUENT FIVE YEAR RENEWALS UNLESS CANCELLED BY WRITTEN NOTICE, FOR A DATA MIGRATION, ANNUAL SUBSCRIPTION AND SUPPORT OF THE SIRSDYNIX SYMPHONY SAAS INTEGRATED LIBRARY SYSTEM, INCLUDING CATALOGING, CIRCULATION, PUBLIC ACCESS AND REPORTS, FOR THE CITY OF HIALEAH PUBLIC LIBRARIES; FURTHER AUTHORIZING THE ANNUAL EXPENDITURES AS PER THE ATTACHED QUOTE, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Hialeah finds that it is in the best interest of the City and its residents to enter into the referenced agreement; and

WHEREAS, the libraries in the city shall run more efficiently and services shall be consolidated within the City; and

WHEREAS, Sirsi Corporation ~~in~~ has effectively and reliably provided ~~sueh~~ its products, maintenance, and support services to the Hialeah Public Libraries for 17 years and has offered the best service at the best price.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY

COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby authorizes the Mayor and the City Clerk, as attesting witness, on behalf of the City, to enter into a Software as a Service (SaaS) Integrated Library System agreement with Sirsi Corporation for five years, with consecutive five year renewals, commencing on the last date signed by either party, subject to cancellation upon written notice.


