

**RESOLUTION NO. 2019-124**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING THE DONATION OF SEVEN (7) SURPLUS POLICE VEHICLES FROM THE CITY'S VEHICLE FLEET; PROVIDING FOR IMPLEMENTATION; PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the seven (7) police vehicles more particularly described in Exhibit "A" are no longer cost effective for the City to maintain and operate and are surplus; and

**WHEREAS**, the pursuant to § 2-901 of the City of Hialeah Code of Ordinances, the City is authorized to donate property to another governmental entity without placing the property for public sale if the donation serves a charitable or public purpose; and

**WHEREAS**, the City Council finds that the donation of the vehicles to the Miami-Dade County K9 Services serves both a charitable and public purpose.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

**Section 2:** The seven (7) police vehicles identified in Exhibit "A" are hereby declared surplus to the City's needs and shall be donated to the Miami-Dade County K9 Services as the donation serves both a charitable and public purpose, and the Mayor or his designee is authorized to execute the documents necessary to accomplish the donation.






