

Municipal Canvassing Board Minutes

November 5, 2019

1. The City of Hialeah Canvassing Board convenes at the Office of the Supervisor of Elections located at 2700 NW 87th Avenue, Miami, Florida 33172. The Canvassing Board is convening for the November 5, 2019 City of Hialeah Primary and Special Elections.

- Canvassing of presumed invalid vote-by-mail ballots
 - 7,561 number of valid ballots
 - The Canvassing Board accepted an additional 87 ballots as legal, for a total of 7,648 valid ballots
 - 226 number of presumed invalid ballots
 - No Signature = 92 ballots were presented to the Canvassing Board
 - Signature Does Not Match = 130 ballots were presented to the Canvassing Board
 - Already Voted = 3 ballots were presented to the Canvassing Board
 - Unknown Voter = 1 ballot was presented to the Canvassing Board
 - The Canvassing Board rejected 139 ballots as illegal.
 - Final total number of ballots is 7,787
