

RESOLUTION NO. 2019-154

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE TOTALING AN AMOUNT NOT TO EXCEED \$12,900.00 FROM THE LAW ENFORCEMENT TRUST FUND – *STATE*, CAPITAL OUTLAY – EQUIPMENT TO PURCHASE 300 NIGHTSTICKS-SAFETY LIGHTS/FLASHLIGHT COMBO KIT FOR THE HIALEAH POLICE DEPARTMENT, FROM GL DISTRIBUTORS, INC., THE LOWEST QUOTE VENDOR, SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE.

WHEREAS, the Hialeah Police Department faces danger when directing traffic or marking a hazardous area; and

WHEREAS, the Hialeah Police Department desires to purchase 300 Nightsticks-Safety Lights/Flashlight Combo Kits in order to ensure that the Hialeah Police Department is able and ready to respond to these situations, prevent crime, and to protect public safety; and

WHEREAS, it is in the best interests of the health, safety, and welfare of the citizens of Hialeah and Miami-Dade county for the officers of the Hialeah Police Department to train with and utilize Nightsticks-Safety Lights and related accessories; and

WHEREAS, GL Distributors, Inc. is the lowest quoted vendor for the Nightsticks-Safety Lights/Flashlight Combo Kit; and

WHEREAS, the funds to cover these necessary and legitimate expenses are available in the Law Enforcement Trust Fund – *State/Capital Outlay* – Equipment.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2: The Mayor and the City Council of the City of Hialeah, Florida, approve the expenditure of an amount not to exceed \$12,900.00 from the Law Enforcement Trust Fund – *State/Capital Outlay* - Equipment, to purchase 300 Nightsticks-Safety Lights/Flashlights Combo Kit from GL Distributors, Inc., the lowest quoted vendor, such costs having been approved by the Chief of Police.






