

**RESOLUTION NO. 2019-167**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA APPROVING THE PURCHASE OF A ONE-HUNDRED FOOT VELOCITY MID-MOUNT LADDER TRUCK MANUFACTURED BY PIERCE AND RELATED EQUIPMENT AND ATTACHMENTS, IN THE TOTAL AMOUNT NOT TO EXCEED \$1,457,428.00, FROM TEN-8 FIRE EQUIPMENT, INC., A FLORIDA CORPORATION; AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO EXECUTE A PURCHASE CONTRACT AND ALL OTHER NECESSARY DOCUMENTS IN FURTHERANCE HEREOF IN A FORM ACCEPTABLE TO THE CITY ATTORNEY; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the City is purchasing a 100-foot Velocity mid-mount ladder truck manufactured by Pierce off a competitively bid contract for fire rescue vehicles and apparatus and ambulances by the Florida Sheriffs Association Cooperative Purchasing Program; and

**WHEREAS**, the Council finds that the purchase of the fire truck based upon the terms and conditions of FSA18-VEF 13.0 Spec 12 Florida Sheriffs Association contract is exempt from competitive bidding pursuant to Hialeah Code Section 2-818; and

**WHEREAS**, the fire truck is essential for the City's performance of its governmental functions and in the best interest of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The foregoing facts and recitations contained in the preamble to this ordinance are hereby adopted and incorporated by reference as if fully set forth herein.


**Section 2:** The City of Hialeah, Florida hereby approves the purchase of a 100-foot Pierce manufactured Velocity mid-mount ladder truck as described in the Equipment Proposal attached to this Resolution as "Exhibit 1" from Ten-8 Fire Equipment, Inc., a Florida Corporation, in the total amount not to exceed \$1,457,428.00 and authorizes the Mayor and the

City Clerk, as attesting witness, on behalf of the City, to execute a purchase contract and/or any other necessary documents in furtherance hereof in a form acceptable to the City Attorney.

**Section 3:    Effective Date.**

This resolution shall become effective when passed by the City Council of the City of Hialeah, Florida and signed by the Mayor of the City of Hialeah, Florida or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.


