Notice is hereby given that the City Council of the City of Hialeah will hold a **VIRTUAL Special Public Meeting at 9:30 a.m. on Thursday, April 23, 2020.** The Special Meeting of the City of Hialeah Employees' Retirement System is called to approve the appropriation or expenditure of public funds on items deemed essential to continue the Board's operations, functions and services during the pendency of the public health emergency.
