

RESOLUTION NO. 2020-058

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA AWARING BID NO. 2019-20-0240-36-002 TO MINNESOTA LIFE INSURANCE COMPANY, THE LOWEST RESPONSIVE RESPONSIBLE BIDDER, FOR BASIC LIFE INSURANCE AND ACCIDENTAL DEATH AND DISMEMBERMENT INSURANCE COVERAGE FOR CITY EMPLOYEES AND RETIREES FOR A TERM OF 3 YEARS AT A RATE NOT TO EXCEED \$0.080 PER \$1,000 COVERAGE FOR FOR ACTIVE EMPLOYEES AND \$.800 PER \$1,000 COVERAGE FOR RETIRED EMPLOYEES FOR BASIC LIFE INSURANCE AND \$0.028 PER \$1,000 COVERAGE FOR ACCIDENTAL DEATH AND DISMEMBERMENT INSURANCE.

WHEREAS, on April 23, 2020, the City Clerk opened sealed bids submitted by Minnesota Life Insurance Company and Metropolitan Life Insurance Company in response to a duly advertised Bid No. 2019-20-0240-36-002 asking for rates for basic life insurance, accidental death and dismemberment insurance for employees and retirees; and

WHEREAS, the City of Hialeah finds that it is in the best interest of the City to award the bid to Metropolitan Life Insurance Company after the City reviewed the bids and found the bid to be the lowest responsive bid from a responsible company.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby awards Bid No. 2019-20-0240-36-002 to Minnesota Life Insurance Company, the lowest responsive responsible bidder, for Basic Life Insurance and Accidental Death and Dismemberment Insurance coverage for City employees and retirees for a term of 3 years at a rate not to exceed \$0.080 per \$1,000 coverage for active

employees and \$.800 per \$1,000 coverage for retired employees for Basic Life Insurance and \$0.028 per \$1,000 coverage for Accidental Death and Dismemberment Insurance.


