

**RESOLUTION NO. 2020-074**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE IN AN AMOUNT NOT TO EXCEED \$22,054.75 FROM THE LAW ENFORCEMENT TRUST FUND-*FEDERAL* FOR THE PURCHASE OF TWENTY-FIVE (25) STREAM LIGHT TLR1-HL WEAPON LIGHTS, TWENTY-FIVE (25) TRIJICON RED DOT MOUNTS AND TWENTY-FIVE (25) GLOCK 17T TRAINING PISTOLS FROM LOU'S POLICE DISTRIBUTORS, INC., LOWEST QUOTED VENDOR, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE, AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, law enforcement officers with the Hialeah Police Department are taught to maintain sense of situational awareness whether responding while on patrol or during SWAT operations; and

**WHEREAS**, situational training teaches police officers to quickly assess the situation and tailor a response when a crisis requires the use of force to regain control of a situation; and

**WHEREAS**, force-on-force training allows officer to train in live-action, reality-based scenarios; and

**WHEREAS**, situational training has proven to encourage police officers to perform more realistically as opposed to force-on-force training that will expose flaws and bad reactions while in a simulated environment; and

**WHEREAS**, situational training will increase the safety of law enforcement officers and members of our community by training police officers to process high-stakes situations more completely and accurately so that they make better decisions and reduce excessive uses of force; and

**WHEREAS**, equipment such as GLOCK17T training pistols, steam light TLR1-HL weapon lights, and Trijicon red dot mounts will be utilized during reality-based tactical operations training using color markings or plastic projectile ammunition; and

**WHEREAS**, the Hialeah Police Department seeks to purchase twenty-five (25) stream light TLR1-HL weapon lights, twenty-five (25) Trijicon red dot mounts and twenty-five (25) GLOCK 17T training pistols from Lou's Police Distributors, Inc., and

**WHEREAS**, Lou's Police Distributors is an active corporation in good standing in the state of Florida; and

**WHEREAS**, funding for this project will be from account 127.1000.521.640 Law Enforcement Trust Fund-*Federal*; and

**WHEREAS**, Section 932.7055, Fla. Stat. (2018), the Florida Contraband and Forfeiture Act, authorizes the expenditure of Law Enforcement Trust Funds-*Federal* for this purpose and the funds are available in the Law Enforcement Trust Fund-*Federal* account for the Police Department; and

**WHEREAS**, the Chief of Police of the Hialeah Police Department has recommended adoption of this resolution and determined that the proposed expenditure complies with the Florida Contraband Forfeiture Act, and all applicable rules, regulations and guidelines governing the expenditure of Law Enforcement Trust Fund-*Federal*; and

**WHEREAS**, the City finds the expenditure is in the public interest;


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.


**Section 2:** The City of Hialeah, Florida hereby approves the expenditure of an amount not exceeding \$22,054.75 from the Law Enforcement Trust Fund-*Federal* for the purchase of twenty-five (25) stream light TLR1-HL weapon lights, twenty-five (25) Trijicon red dot mounts and twenty-five (25) GLOCK 17T training pistols from Lou's Police Distributors, Inc., lowest quoted vendor, upon such costs having been approved by the Chief of Police of the Hialeah Police Department having specifications and pursuant to the terms and conditions as set forth in "Exhibit 1."


**Section 3:** This resolution shall become effective when passed by the City Council and signed by the Mayor.

Dear Mayor Hernandez and Council Members:


The Charter of Hialeah states that contracts in amounts greater than \$15,000.00 shall be awarded on the basis of specifications and formal sealed bids. The Council may award a contract to the lowest responsible and responsive bidder, or it may reject all bids and re-advertise; or it may waive competitive bidding when it finds it to be the best interest of the City.

Situational training has proven to take officers to the edge and encourage them to perform more realistically whereas Force-on-Force training will expose flaws and bad reactions while in a simulated environment. High stress levels and the resulting drop in accuracy, situation awareness and thought-through reactions show officers what they need to expect when real situations go bad. The purchase of the Glock17T training pistol along with the stream light TLR1-HL weapon light and Trijicon red dot mount will be utilized for reality-based tactical operations training using color marking or plastic projectile ammunition.

Lou's Police Distributors, Inc. is the lowest quoted vendor and is in good standing in the State of Florida and is an active corporation.



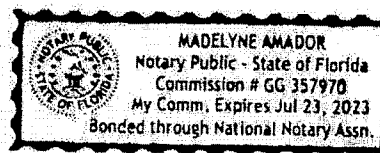

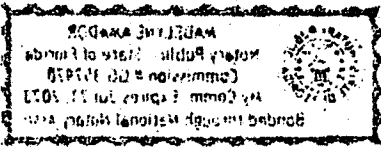
