RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA ACCEPTING THE GRANT AWARD FROM THE MIAMI-DADE COUNTY DEPARTMENT OF CULTURAL AFFAIRS UNDER THE TARGETED INITIATIVES GRANTS PROGRAM, IN THE AMOUNT OF \$30,000.00, FOR FISCAL YEAR 2019-2020, TO SUPPORT THE CITY'S JULY 4<sup>TH</sup> CELEBRATION, HISPANIC HERITAGE MONTH SERIES EVENTS AND MILANDER GALLERY EVENTS; AND FURTHER AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO ENTER INTO A GRANT AWARD AGREEMENT COMMENCING ON OCTOBER 1, 2019 AND ENDING ON SEPTEMBER 30, 2020, IN FURTHERANCE THEREOF; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the City of Hialeah is continuously searching for available grants as a source of funding to support the maintenance and growth of its special events and programming for the community at large;

**WHEREAS**, pursuant to Hialeah, Fla., Resolution 2019-058 (June 6, 2019), the City entered into a one year agreement, in the amount of \$30,000.00, with the Miami-Dade County Department of Cultural Affairs, under the Targeted Initiatives Grants Program for fiscal year 2019-2020;

**WHEREAS**, the Miami-Dade Department of Cultural Affairs, under its Targeted Initiatives Grants Program, notified the City of Hialeah of a grant awarded to the City in the amount of \$30,000.00, for fiscal year 2018-2019, to support the City's July 4<sup>th</sup> Celebration, Hispanic Heritage Month Series events and Milander Gallery events.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The foregoing facts and recitations contained in the preamble to this resolution are hereby incorporated and adopted by reference as if fully set forth herein.

**Section 2:** The City of Hialeah, Florida hereby accepts the grant award from the Miami-Dade County Department of Cultural Affairs, under the Targeted Initiatives Grants Program, in the amount of \$30,000.00, for fiscal year 2019-2020, to support the City's July 4<sup>th</sup> Celebration, Hispanic Heritage Month Series events, and Milander Gallery events.

**Section 3:** The City of Hialeah, Florida hereby authorizes the Mayor and the City Clerk, as attesting witness, on behalf of the City, to enter into a Grant Award Agreement, commencing on October 1, 2019 and ending on September 30, 2020, in furtherance thereof. All actions taken to date by officers of the City in furtherance of the performance of this Grant Award Agreement, are hereby approved, confirmed and ratified.






