RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AMENDING HIALEAH FLORIDA RESOLUTION NO. 2020-108 (AUGUST 11, 2020), WHICH AUTHORIZED THE MAYOR OR HIS DESIGNEE ON BEHALF OF THE CITY OF HIALEAH TO SUBMIT TO THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) THE ACTION PLAN, AND THE ACTION PLAN BUDGETS FOR FISCAL YEAR 2020-2021, WHICH INCLUDED THE ALLOCATION FOR SELECTED PROGRAMS FOR CDBG, HOME AND ESG AND AWARDED SUB-RECIPIENTS, TO INCLUDE A GRANT AWARD UNDER THE CDBG PROGRAM TO AN ADDITIONAL SUB-RECIPIENT, AS SET FORTH IN THE UPDATED ATTACHMENT E, A COPY OF WHICH IS ATTACHED HEREAFTER AND INCORPORATED HEREIN; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, in order for the City to receive federal funds for the next fiscal year for the HOME investment Partnership (HOME), the Community Development Block Grant (CDBG), and the Emergency Solutions Grant (ESG) programs, the City is required to submit an Action Plan, which describes the activities to be undertaken for these programs for Fiscal Year commencing on October 1, 2020 and ending on September 30, 2021;

WHEREAS, pursuant to Hialeah Florida Resolution No. 2020-108 (August 11, 2020), the City Council authorized the Mayor or his designee on behalf of the City to submit to the United States Department of Housing and Urban Development (HUD) the Action Plan, and the Action Plan budgets for Fiscal Year 2020-2021, which included the allocation for selected programs for CDBG, HOME and ESG and awarded sub-recipients, and further authorized the Mayor or his designee to execute any and all agreements, certifications, and assurances in furtherance of the programs in the Action Plan, in accordance with the applicable US HUD regulations; and

WHEREAS, the City wishes to replace Attachment E, to include a grant award under the CDBG program to an additional sub-recipient.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby amends Hialeah Florida Resolution No. 2020-108 (August 11, 2020), which authorized the Mayor or his designee on behalf of the City of Hialeah to submit to the United States Department of Housing and Urban Development (HUD) the Action Plan, and the Action Plan budgets for Fiscal Year 2020-2021, which included the allocation for selected

programs for CDBG, HOME and ESG and awarded sub-recipients, to include a grant award under the CDBG program to an additional sub-recipient, as set forth in the updated Attachment E, a copy of which is attached hereafter and incorporated herein







RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING THE MAYOR OR HIS DESIGNEE ON BEHALF OF THE CITY OF HIALEAH, FLORIDA, TO SUBMIT TO THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) THE ACTION PLAN. THE ACTION PLAN BUDGETS FOR FISCAL YEAR 2020-2021, ATTACHED AS EXHIBIT A-E, INCLUDES THE ALLOCATIONS AND SELECTED PROGRAMS FOR CDBG, HOME AND ESG AND AWARDED SUB-RECIPIENTS, AND TO EXECUTE ANY AND ALL AGREEMENTS, CERTIFICATIONS AND ASSURANCES IN FURTHERANCE OF THE PROGRAMS IN THE ACTION PLAN IN ACCORDANCE WITH THE US HUD REGULATIONS.




