

**RESOLUTION NO. 2018-033**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO RENEW A SERVICES AGREEMENT WITH CLAUDIA SANTANA, IN SUBSTANTIAL CONFORMITY WITH THE AGREEMENT ATTACHED AND MADE A PART HEREOF AS EXHIBIT "1", FOR A TERM OF TWELVE MONTHS, COMMENCING ON MARCH 23, 2018 THROUGH MARCH 23, 2019; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, on or about March 22, 2017, the City and Claudia Santana entered into a Service Agreement ("Original Agreement") whereby Claudia Santana agreed to provide adult fitness instruction classes at designated City-owned recreational centers, for a term of twelve (12) months, with the option to renew for an additional twelve-month term;

**WHEREAS**, pursuant to the Original Agreement, upon mutual agreement, the parties have the option to renew the Original Agreement for an additional term of twelve (12) months, upon similar terms and condition, provided that Claudia Santana sent written notification to the City sixty (60) days prior to the expiration of the Original Agreement exercising its option to renew the Original Agreement; and

**WHEREAS**, the parties mutually agree to renew the Original Agreement for one term of twelve months, provided that all of the terms, conditions, requirements and specifications contained in the Original Agreement remain in full force and effect during the renewal term.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The Recitals are true and correct and are hereby incorporated into and made a part of this Agreement.

**Section 2.** The City of Hialeah, Florida hereby authorizes the Mayor and the City Clerk, as attesting witness, on behalf of the City, to renew a Services Agreement with Claudia Santana, in substantial conformity with the Agreement attached and made a part hereof as Exhibit "1", for a term of twelve months, commencing on March 23, 2018 through March 23, 2019. All action taken to date by officers and employees of the City in furtherance of the performance of this Agreement is hereby approved, confirmed and ratified.




