

RESOLUTION NO. 2020-135

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE IN AN AMOUNT NOT TO EXCEED \$342,525.00 FROM THE LAW ENFORCEMENT TRUST FUND-*STATE* FOR THE PURCHASE OF TWENTY-FIVE (25) NIGHT VISION GOGGLES (L3 WARRIOR SYSTEMS) AND TWENTY-FIVE (25) ADVANCED TARGET POINTER ILLUMINATOR AIMING LASERS FROM SRT SUPPLY, LOWEST QUOTED VENDOR, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, it is the practice of the Hialeah Police Department to respond quickly and effectively to any situation, including hostage barricades and active shooter situations, in the most professional manner possible to protect life and property; and

WHEREAS, Special Weapons and Tactics Team (SWAT) in the Hialeah Police Department is a law enforcement unit which uses specialized or military equipment and tactics; and

WHEREAS, the K9 Team in the Hialeah Police Department is a law enforcement unit which uses canine partners to enforce the law, detect illegal substances such as narcotics and explosives, apprehend criminals, and track and rescue kidnapped or missing persons; and

WHEREAS, SWAT operators and K9 Team members in the Hialeah Police Department are in need of night vision goggles (LE Warrior Systems) and advanced target pointer illuminator aiming laser which allow sworn officers to conduct nighttime surveillance, fully function safely in the dark, reduce the chance of an armed encounter by creating superior situational awareness, and enhance precision for nighttime direct-fire; and

WHEREAS, SRT Supply is an active corporation in good standing in the state of Florida and is the lowest quoted vendor; and

WHEREAS, funding for this project will be from account 105.1000.521.640 Law Enforcement Trust Fund-*STATE*; and

WHEREAS, Section 932.7055, Fla. Stat. (2018), the Florida Contraband and Forfeiture Act, authorizes the expenditure of Law Enforcement Trust Funds-*STATE* for this purpose and the funds are available in the Law Enforcement Trust Fund-*STATE* account for the Police Department; and

WHEREAS, the Chief of Police of the Hialeah Police Department has recommended adoption of this resolution and determined that the proposed expenditure complies with the Florida Contraband Forfeiture Act, and all applicable rules, regulations and guidelines governing the expenditure of Law Enforcement Trust Fund-*STATE*; and

WHEREAS, the City finds the expenditure is in the public interest;


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby approves the expenditure of an amount not exceeding \$342,525.00 for twenty-five (25) Night Vision Goggles (L3 Warrior Systems) and twenty-five (25) advanced target pointer illuminator aiming lasers itemized in "Exhibit 1" (attached hereto) from SRT Supply, lowest quoted vendor, from the Law Enforcement Trust Fund-*STATE*, upon such costs having been approved by the Chief of Police of the Hialeah Police Department having specifications and pursuant to the terms and conditions as set forth in "Exhibit 1."


Section 3: This resolution shall become effective when passed by the City Council and signed by the Mayor.



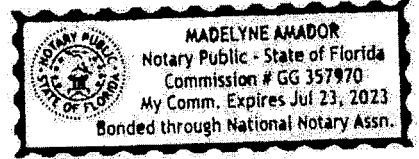
