

**RESOLUTION NO. 2020-155**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE IN AN AMOUNT NOT TO EXCEED \$53,291.24 FROM L.E.T.F. STATE CAPITAL OUTLAY- EQUIPMENT GRANT ACCOUNT #105.1000.521640 FOR THE PURCHASE OF INVESTIGATIVE TOOLS WHICH INCLUDES TWO (2) CORE FLEX CAMERA HEADS, TWO (2) CORE POLE CAMERA KITS AND TWO (2) CORE UNDER THE DOOR CAMERA KITS FROM STRACK, INC., THE LOWEST QUOTED VENDOR, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE, AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Hialeah Police Department needs to replace investigative camera equipment; and

**WHEREAS**, the CORE Flex camera is an investigative tool utilized in high stress situations, providing law enforcement officers with helpful information while keeping the officer at a safe distance; and

**WHEREAS**, the CORE Flex camera combines extreme low light sensitivity with thermal fusion technology to provide unsurpassed detail and definition; and

**WHEREAS**, Strack, Inc. has provided a quote for the equipment via the govquote platform and Strack, Inc. is the lowest quoted vendor; and

**WHEREAS**, Strack Inc. is an active corporation in good standing in the State of Florida; and

**WHEREAS**, an amount not to exceed \$53,291.24 will be drawn from grant account #105.1000.521640 L.E.T.F. Capital Outlay – Equipment for the purchase of two (2) CORE Flex Camera Heads, two (2) CORE Pole Camera Kits, and two (2) CORE under the door Camera Kits; and

**WHEREAS**, funding for this project will be from account 127.1000.521.640 Law Enforcement Trust Fund-*State*; and

**WHEREAS**, Section 932.7055, Fla. Stat. (2018), the Florida Contraband and Forfeiture Act, authorizes the expenditure of Law Enforcement Trust Funds-*State* for this purpose and the funds are available in the Law Enforcement Trust Fund-*State* account for the Police Department; and

**WHEREAS**, the Chief of Police of the Hialeah Police Department has recommended adoption of this resolution and determined that the proposed expenditure complies with the Florida Contraband Forfeiture Act, and all applicable rules, regulations and guidelines governing the expenditure of Law Enforcement Trust Fund-*State*; and

**WHEREAS**, the Chief of Police of the City of Hialeah Police Department has recommended adoption of this resolution; and

**WHEREAS**, the City finds the expenditure is in the public interest;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:


**Section 1:** The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

**Section 2:** The City of Hialeah, Florida hereby approves the expenditure of an amount not exceeding \$53,291.24 from grant account #105.1000.521640 L.E.T.F. Capital Outlay – Equipment for the purchase of two (2) CORE Flex Camera Heads, two (2) CORE Pole Camera Kits, and two (2) CORE under the door Camera Kits from Strack, Inc., lowest quoted vendor, having specifications and pursuant to the terms and conditions as set forth in “Exhibit 1.”


**Section 3:** This resolution shall become effective when passed by the City Council and signed by the Mayor.



Report of Scrivener's Error—On November 10, 2020 the City Council approved Resolution No. 2020-155 (Item G) approving an expenditure in an amount not to exceed \$53,291.24 from L.E.T.F. 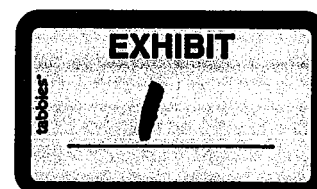

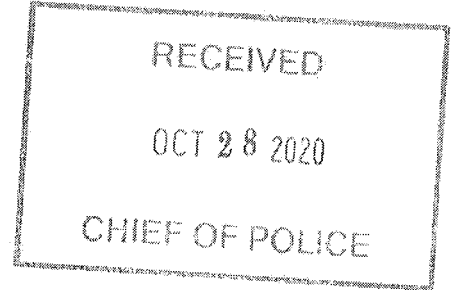


Dear Mayor Hernandez and Council Members:

The Charter of Hialeah states that contracts in amounts greater than \$15,000.00 shall be awarded on the basis of specifications and formal sealed bids. The Council may award a contract to the lowest responsible and responsive bidder, or it may reject all bids and re-advertise; or it may waive competitive bidding when it finds it to be the best interest of the City.

The Hialeah Police Department will be replacing its investigative camera kit. The CORE Flex camera is an investigative tool utilized in high stress situations providing officers with helpful information while keeping them at a safe distance.

Funding for this purchase is provided by the Law Enforcement Trust Fund (LETF). Quotes were obtained via the govquote platform (web based marketplace). 1,215 companies were notified through the platform and five responded. Of the five companies, three provided quotes. Strack, Inc. is the lowest quoted vendor. Strack, Inc. is an active corporation and is in good standing in the State of Florida. 

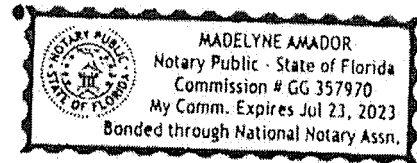

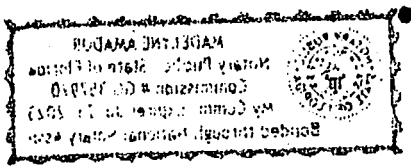
