

**RESOLUTION NO. 2020-188**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AMENDING HIALEAH FLORIDA RESOLUTION NO. 2020-108 (AUGUST 11, 2020), WHICH AUTHORIZED THE MAYOR OR HIS DESIGNEE ON BEHALF OF THE CITY TO SUBMIT TO THE UNITED STATES DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) THE ACTION PLAN, AND THE ACTION PLAN BUDGETS FOR FISCAL YEAR 2020-2021, TO PROVIDE FOR A DECREASE IN THE TOTAL ALLOCATION FOR THE CDBG AND HOME GRANTS, AND CORRESPONDING REDUCTION OF ADMINISTRATION COSTS FOR THE CDBG AND HOME GRANTS IN THE AMOUNT OF \$432.00 AND \$431.00, RESPECTIVELY; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, in order for the City to receive federal funds for the next fiscal year for the HOME investment Partnership (HOME), the Community Development Block Grant (CDBG), and the Emergency Solutions Grant (ESG) programs, the City is required to submit an Action Plan, which describes the activities to be undertaken for these programs for Fiscal Year commencing on October 1, 2020 and ending on September 30, 2021; and

**WHEREAS**, pursuant to Hialeah Florida Resolution No. 2020-108 (August 11, 2020), the City Council authorized the Mayor or his designee on behalf of the City to submit to the United States Department of Housing and Urban Development (HUD) the Action Plan, and the Action Plan budgets for Fiscal Year 2020-2021, which included the allocation for selected programs for CDBG, HOME and ESG and awarded sub-recipients, and further authorized the Mayor or his designee to execute any and all agreements, certifications, and assurances in furtherance of the programs in the Action Plan, in accordance with the applicable US HUD regulations; and

**WHEREAS**, pursuant to Hialeah Florida Resolution No. 2020-126 (September 22, 2020), the City Council amended Hialeah Florida Resolution No. 2020-108 (August 11, 2020), to include a grant award under the CDBG Program to an additional sub-recipient; and

**WHEREAS**, U.S. HUD has notified the City of a decrease in the total allocations for the CDBG and HOME Grants;

**WHEREAS**, the original total allocations for the CDBG and HOME Grants were \$2,832,380.00 and \$1,486,799.00, respectively, and the new allocations are \$2,831,928.00 and \$1,486,368.00, respectively; and

**WHEREAS**, the City wishes to amend the action plan budget to reflect the reduction by reducing amounts allocated for Administration costs for each of the CDBG and HOME Grants.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

**Section 2:** The City of Hialeah, Florida hereby amends Hialeah Florida Resolution No. 2020-108 (August 11, 2020), approving the U.S. Housing and Urban Development Grants Action Plan and Action Plan budgets for Fiscal Year 2020-2021, reducing the total allocation for the CDBG and HOME Grants, including a reduction to administration costs for the CDBG and HOME Grants in the amount of \$432.00 and \$431.00, respectively.






