Please be advised that on the date, time and location indicated above, the City Council will meet to discuss possible funding sources for the Freebee transportation solution.

Consistent with the meeting guidelines adopted on April 14, 2020 by Hialeah, Fla. Resolution 2020-048, as amended on November 10, 2020 by Hialeah, Fla. Resolution 2020-160 for public meetings during the health pandemic, only 15 members of the public will be allowed to be present in Chambers considering the physical spacing limitations and social distancing requirements. Seating will be on a first-come-first serve basis. Based upon anticipated in-person attendance of any meeting, the City may provide additional space at City Hall to accommodate the public and provide both viewing and participation capabilities. In addition, all public meetings continue to be broadcast live for members of the public to view on the City's Facebook page. As an additional alternative, members of the public may hear or view the meeting live through telephonic or video conferencing by using any telephone, cellular phone, smart device or computer and accessing the Zoom meeting dial or log-in information provided in this notice.
