RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE MEMORANDUM OF UNDERSTANDING (MOU) AGREEMENT WITH PLAY FOR CHANGE, INC., (PFC) TO MUTUALLY DEVELOP PROGRAMS IN THE PARKS AND RECREATION DEPARTMENT WITH THE GOAL OF HELPING DISADVANTAGED CHILDREN TO USE SPORT AS A TOOL TO HELP THE CHILDREN DEVELOP LIFE SKILLS, IN THE FORM ATTACHED HERETO AS EXHIBIT "1", WITH ONE YEAR SUCCESSIVE ANNUAL RENEWALS AND FREE TO THE CITY'S PATRONS WHO RESIDE IN HIALEAH; AND AUTHORIZING THE MAYOR ON BEHALF OF THE CITY, TO ENTER INTO THE MOU, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City desires to enter into a Memorandum of Understanding (MOU) with Play for Change, Inc. (PFC) to promote programs with the goal of helping disadvantaged children to use sport as a tool to develop life skills for their future; and

WHEREAS, Play for Change, Inc. (PFC) is dedicated to improving the lives of vulnerable children around the world using the power of sport to improve education and build life skills through sport that plays a significant role in children's cognitive, emotional and physical development; and

WHEREAS, Play for Change, Inc. (PFC) the City of Hialeah finds it is in the best interest of the City to work together to foster collaboration among both parties' constituents, and create synergies around sports and implement interactive cooperation between both organizations, particularly, where participation is free to Hialeah residents.


THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The City of Hialeah, Florida hereby authorizes the Mayor on behalf of the City, to enter into a Memorandum of Understanding (MOU) with Play for Change, Inc. (PFC) to promote programs with the goal of helping disadvantaged children to use sport as a tool to help the children develop life skills in the form as attached hereto as Exhibit "1", with two successive annual renewals.

Section 2: **Effective Date.**




