RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING THE TRANSFER OF UNENCUMBERED APPROPRIATION BALANCE OR A PORTION THEREOF BETWEEN CLASSIFICATIONS OF EXPENDITURES WITHIN AN OFFICE OR DEPARTMENT WITHIN THE GENERAL FUND AND WITHIN THE SPECIAL REVENUE FUNDS, IN PARTICULAR, THE STREETS FUND, FIRE RESCUE FUND, PARK GRANT & IMPACT FEE FUND, AFFORDABLE HOUSING FUND, AND BUILDING DIVISION FUND; AND WITHIN THE CAPITAL FUND, IN PARTICULAR, GOODLET ADULT CENTER FUND; AND WITHIN THE PUBLIC WORKS FUNDS, IN PARTICULAR, THE SOLID WASTE FUND AND WATER & SEWER FUND, ALL TRANSFERS AS SUMMARIZED AND ITEMIZED IN THE SCHEDULE ATTACHED AND MADE A PART HEREOF AS "EXHIBIT A".


**WHEREAS**, based on actual experience during the first six months of Fiscal Year 2020-2021, the line item adjustments identified do not increase or decrease the budgets of the General Fund, designated Special Revenue Funds, designated Capital Fund and designated Enterprise Fund of the City.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The City of Hialeah, Florida, hereby authorizes the transfer of unencumbered appropriation balances or a portion thereof between classifications of expenditures within one office or department within the General Fund; within the Special Revenue Funds, in particular, Streets Fund, Fire Rescue Fund, Park Grant & Impact Fees Fund, Affordable Housing Fund, Building Division Fund; within the Capital Funds, in particular, the Goodlet Adult Center Fund; and within the Public Works Funds, in particular, Solid Waste Fund and Water & Sewer Fund, all transfers made as summarized and itemized in the schedule attached and made a part hereof as Exhibit "A".


**Section 2:** This resolution shall become effective when passed by the City Council of the City of Hialeah, Florida and signed by the Mayor of the City of Hialeah, Florida or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.


