RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING THE DEPARTMENT OF GRANTS AND HUMAN SERVICES TO APPLY FOR THE DEPARTMENT OF ECONOMIC OPPORTUNITY COMMUNITY DEVELOPMENT BLOCK GRANT (“DEO CV”) PROGRAM FOR \$1,361,658.00, TO ESTABLISH A BROADBAND PROJECT AT LOCATIONS DESCRIBED IN EXHIBIT “A”; AUTHORIZING THE DIRECTOR OF THE GRANTS AND HUMAN SERVICES DEPARTMENT AND THE INFORMATION TECHNOLOGY DIRECTOR TO ENTER INTO AN INTER-DEPARTMENTAL MEMORANDUM OF UNDERSTANDING FOR THE LATTER TO PROCURE AND MANAGE THE BROADBAND PROJECT, AND FURTHER AUTHORIZING THE DIRECTOR OF THE GRANTS AND HUMAN SERVICES DEPARTMENT TO EXECUTE ALL OTHER NECESSARY DOCUMENTS AND CONDUCT ALL NECESSARY PUBLIC HEARINGS AS REQUIRED BY LAW IN FURTHERANCE THEREOF; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the City of Hialeah is qualified to apply for the Department of Economic Opportunity Community Development Block Grant (DEO-CV) funds; and

**WHEREAS**, the DEO CV program provides funds to manage public health and safety issues in an attempt to mitigate the effects of the Covid-19 Pandemic; and

**WHEREAS**, the City wishes to establish a broadband project in public buildings located through the City of Hialeah for the benefit of the community; and

**WHEREAS**, the broadband project shall provide the community with much needed access to the internet to receive information related to health and safety and to apply for financial assistance for the varying federal, state and local programs instituted to mitigated the effects of the Covid-19 pandemic; and

**WHEREAS**, the Grants and Human Services Department, wishes to partner with the Information Technology Department to procure and manage the installation of the equipment needed to provide this service,

**WHEREAS**, the City of Hialeah finds it in the best interest of the community to establish this broadband project to for the benefit of the community at the selected City of Hialeah public properties described in Exhibit “A”.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.



**Section 2:** The City of Hialeah, Florida hereby approves the application and establishment of broadband project to be funded under by the Department of Economic Opportunity (“DEO CV”) program, for the purpose of providing residents and employees with internet access at the selected City of Hialeah public properties described in Exhibit “A”.


**Section 3:** The City of Hialeah, Florida hereby authorizes the Director of the Grants and Human Services Department and the Information Technology Director to enter into an Inter-Departmental Memorandum of Understanding, for the procurement and management of the equipment needed to provide this service to the community, and further authorizes the Director of the Grants and Human Services Department to execute all other necessary documents in furtherance thereof. All actions taken to date by officers of the City in furtherance and performance of this program and the Memorandum of Understanding are hereby approved, confirmed, and ratified.

**Section 4:** This resolution shall become effective when approved by majority vote of the City Council and signed by the Mayor or at the next regularly scheduled City Council meeting, if the Mayor’s signature is withheld or if the City Council overrides the Mayor’s veto.



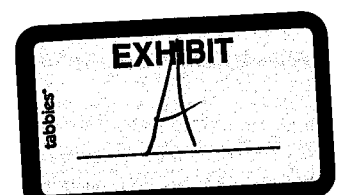
