

**RESOLUTION NO. 2017-044**

A RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA AMENDING HIALEAH, FLA. RESOLUTION NO. 2016-73 (AUGUST 18, 2016), WHICH ACCEPTED A GRANT AWARD FROM THE CHILDREN'S TRUST IN THE AMOUNT OF \$363,656.00, FOR ONE-YEAR COMMENCING ON AUGUST 1, 2016 THROUGH JULY 31, 2017, AND AUTHORIZED THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO ENTER INTO A GRANT AGREEMENT IN A FORM ACCEPTABLE TO THE CITY ATTORNEY, TO REFLECT A REDUCTION OF THE FUNDING AMOUNT FROM \$363,656.00 TO \$298,799.00, AND AUTHORIZE THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO EXECUTE AMENDMENT NO. 1 TO THE GRANT AGREEMENT, ATTACHED HERETO IN SUBSTANTIAL FORM, AND MADE A PART HEREOF AS EXHIBIT "1"; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, pursuant to Hialeah, Fla. Resolution No. 2016-73 (August 18, 2016), the Mayor and the City Council accepted a grant award from the Children's Trust in the amount of \$363,656.00 for youth enrichment, employment and support programs, for one-year commencing on August 1, 2016 through July 31, 2017, and authorized the Mayor and the City Clerk, as attesting witness, on behalf of the City, to enter into a Grant Agreement in a form acceptable to the City Attorney;

**WHEREAS**, the Children's Trust has reduced the funding amount from \$363,656.00 to \$298,799.00 and has modified other grant requirements including, the service locations, activities, participants outcomes, staffing plan, fiscal requirements, ownership and licensing;

**WHEREAS**, the Grant Agreement previously executed pursuant to Hialeah, Fla. Resolution No. 2016-73 (August 18, 2016), needs to be amended to reflect the proposed changes; and

**WHEREAS**, the City of Hialeah finds it in the best interest of the health, safety and welfare of the community to accept the grant award to benefit its children and residents and enter into an amended grant agreement accordingly.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA; THAT:


**Section 1:** The foregoing facts and recitations contained in the preamble to this Resolution are hereby incorporated and adopted by reference as if fully set forth herein.

**Section 2:** The Mayor and City Council of the City of Hialeah hereby amend Hialeah, Fla. Resolution No. 2016-73 (August 18, 2016), which accepted a grant award from the Children's Trust in the

amount of \$363,656.00, for one-year commencing on August 1, 2016 through July 31, 2017, and authorized the Mayor and the City Clerk, as attesting witness, on behalf of the City, to enter into a Grant Agreement in a form acceptable to the City Attorney, to reflect a reduction of the funding amount from \$363,656.00 to \$298,799.00, and authorize the Mayor and the City Clerk, as attesting witness, on behalf of the City, to execute Amendment No. 1 to the Grant Agreement, attached hereto in substantial form, and made a part hereof as Exhibit "1".






