

RESOLUTION NO. 2017-045

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA AWARING BID NO. 2016-17-0240-00-005 FOR BASIC LIFE INSURANCE AND ACCIDENTAL DEATH AND DISMEMBERMENT INSURANCE COVERAGE FOR CITY EMPLOYEES AND RETIREES, TO THE LOWEST RESPONSIBLE, RESPONSIVE BIDDER FROM A RESPONSIBLE COMPANY, METROPOLITAN LIFE INSURANCE COMPANY, AT A RATE NOT TO EXCEED \$0.220 PER \$1,000 COVERAGE FOR FOR ACTIVE EMPLOYEES AND \$.800 PER \$1,000 COVERAGE FOR RETIRED EMPLOYEES FOR BASIC LIFE INSURANCE, \$0.028 PER \$1,000 COVERAGE FOR ACCIDENTAL DEATH AND DISMEMBERMENT INSURANCE, AND AT THE SAME RATES FOR ADDITIONAL MANAGEMENT AND ADDITIONAL SWORN POLICE LIFE INSURANCE TO BE PAID BY THE EMPLOYEE AND RETIREE; AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO ENTER INTO AN AGREEMENT, IN A FORM ACCEPTABLE TO THE CITY ATTORNEY.

WHEREAS, on May 2, 2017, the City Clerk opened sealed bids submitted by Minnesota Life Insurance Company and Metropolitan Life Insurance Company in response to a duly advertised Bid No. 2016-17-0240-00-005 soliciting rates for basic life insurance, accidental death and dismemberment insurance, additional management life insurance, additional life insurance for sworn police officers; and

WHEREAS, the City has concluded that the bid submitted by Metropolitan Life Insurance Company is responsive to the City's Bid and provides the lowest total cost; and

WHEREAS, the City of Hialeah finds that it is in the best interest of the City to award the bid to Metropolitan Life Insurance Company.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby awards Bid No. 2016-17-0240-00-005 for Basic Life Insurance and Accidental Death and Dismemberment Insurance coverage for City employees and retirees to Metropolitan Life Insurance Company as the lowest responsive, responsible bidder, at a rate not to exceed \$0.220 per \$1,000 coverage for active employees and \$.800 per \$1,000 coverage for retired employees for Basic Life Insurance, \$0.028 per \$1,000 coverage for Accidental Death and Dismemberment Insurance, and for the same rates for additional management and additional sworn police life insurance to be paid by the employee and retiree.

Section 3: The City of Hialeah, Florida further authorizes the Mayor and the City Clerk, as attesting witness, on behalf of the City, to enter into an agreement not exceeding a term of three years, in a form acceptable to the City Attorney.


