RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA ACCEPTING THE GRANT AWARD FROM THE MIAMI-DADE COUNTY DEPARTMENT OF CULTURAL AFFAIRS UNDER THE TARGETED INITIATIVES GRANTS PROGRAM IN THE AMOUNT OF \$30,000, FOR FISCAL YEAR 2016-2017 TO SUPPORT THE CITY'S JULY 4TH CELEBRATION AND HISPANIC HERITAGE MONTH SERIES EVENTS; AND FURTHER AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO ENTER INTO A GRANT AWARD AGREEMENT COMMENCING ON OCTOBER 1, 2016 AND ENDING ON SEPTEMBER 30, 2017, IN FURTHERANCE THEREOF; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Hialeah is continuously searching for available grants as a source of funding to support the maintenance and growth of its special events and programming for the community at large:

WHEREAS, pursuant to Hialeah, Fla., Resolution 2016-04 (January 12, 2016), the City entered into a one year grant agreement, in the amount of \$30,000, with the Miami-Dade County Department of Cultural Affairs, under the Targeted Initiatives Grants Program for fiscal year 2015-2016:

WHEREAS, the Miami-Dade Department of Cultural Affairs, under its Targeted Initiatives Grants Program, notified the City of Hialeah on May 10, 2017 of a grant awarded to the City in the amount of \$30,000 for fiscal year 2016-2017, to support the City's July 4th Celebration, Hispanic Heritage Month Series events and other special events.

WHEREAS, the City of Hialeah finds it in the best interest of the community to accept the grant award from the Miami-Dade County Department of Cultural Affairs.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:


Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby incorporated and adopted by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby accepts the grant award from the Miami-Dade County Department of Cultural Affairs, under the Targeted Initiatives Grants Program in the amount of \$30,000, for fiscal year 2016-2017 to support the City's July 4TH Celebration, Hispanic Heritage Month Series events, and other special events.

Section 3: The City of Hialeah, Florida hereby authorizes the Mayor and the City Clerk, as attesting witness, on behalf of the City, to enter into a Grant Award Agreement commencing on October 1, 2016 and ending on September 30, 2017 in furtherance thereof.






