RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING AND RATIFYING THE NON-EXCLUSIVE CONCESSION MANAGEMENT SERVICES AGREEMENT BETWEEN CONCESSION MANAGEMENT SYSTEMS, LLC AND THE CITY OF HIALEAH, FLORIDA, A COPY OF WHICH IS ATTACHED HERETO AND MADE A PART HEREOF AS EXHIBIT "1", TO PROVIDE CONCESSION MANAGEMENT SERVICES TO THE CITY AT DESIGNATED LOCATIONS FOR A QUARTERLY FEE OF \$4,250.00, FOR A TERM OF ONE YEAR COMMENCING ON APRIL 21, 2017 AND ENDING ON APRIL 20, 2018, WITH AN OPTION TO RENEW FOR THREE CONSECUTIVE ONE-YEAR TERMS; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Concession Management Systems, LLC is a concession catering company that provides food and beverage services for the public at designated locations;

WHEREAS, Concession Management Systems, LLC has agreed to provide concession management services to the City at designated locations for a quarterly fee of \$4,250.00, for a term of one year commencing on April 21, 2017 and ending on April 20, 2018, with an option to renew for three consecutive one-year terms, pursuant to the terms and conditions set forth in the agreement attached hereto and incorporated herein as Exhibit "1" ("Agreement"); and

WHEREAS, Concession Management Systems, LLC has made representations to the City, and the City has relied on Concession Management Systems, LLC's representations about its experience, equipment, manpower, capacity, permits and licenses to perform all concession management services for the City under the Agreement.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:


Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby incorporated and adopted by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby approves and ratifies the Non-Exclusive Concession Management Services Agreement between Concession Management Systems, LLC and the City of Hialeah, Florida, a copy of which is attached hereto and made a part hereof as Exhibit "1", to provide non-exclusive concession management services to the City at designated locations for a quarterly fee of \$4,250.00, for a term of one year commencing on April 21, 2017 and ending on April 20, 2018, with an option to renew for three consecutive one-year terms. All

action taken to date by officers of the City in furtherance of the performance of this agreement is hereby approved, confirmed and ratified.

Section 3: This resolution shall become effective when approved by majority vote of the City Council and signed by the Mayor or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.




