

**RESOLUTION NO. 2017-073**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA ACCEPTING AND APPROVING THE RENEWAL OF THE FLORIDA'S TWENTY-FIRST (21<sup>ST</sup>) CENTURY COMMUNITY LEARNING CENTERS GRANT TO FUND AFTERSCHOOL AND SUMMER PROGRAMS OPERATING OUT OF TWO 21<sup>ST</sup> CENTURY COMMUNITY LEARNING CENTERS SITES, FOR STUDENTS FROM GRADES 6 THROUGH 12, IN THE AMOUNT OF \$422,274.00 FOR THE FOURTH YEAR OF FUNDING COMMENCING ON AUGUST 1, 2017 AND ENDING ON JULY 31, 2018; RATIFYING THE GRANT AGREEMENT; AND FURTHER AUTHORIZING THE MAYOR OR HIS DESIGNEE TO EXECUTE ANY AND ALL AGREEMENTS, DOCUMENTS AND SUBCONTRACTS IN FURTHERANCE THEREOF.

**WHEREAS**, the City of Hialeah applied for a grant with the Florida Department of Education for a 21<sup>st</sup> Century Grant to provide two 21<sup>st</sup> Century Community Learning Centers Sites for afterschool and summer programs for students from Grades 6 through 12 attending Jose Marti MAST Academy and the City of Hialeah Educational Academy;

**WHEREAS**, the Florida Department of Education awarded the grant to the City of Hialeah in an amount of \$699,922.00 for the first year, which the City accepted pursuant to Hialeah, Florida Resolution No. 2015-19 (February 10, 2015);

**WHEREAS**, this grant award is part of a five-year grant cycle in which the Department of Education will fund the first year entirely and on a five percent (5%) declining award amount each subsequent year for years two through five; and


**WHEREAS**, the City of Hialeah finds it in the best interest of the health, safety and welfare of the community to approve the renewal of the grant award to benefit students with quality afterschool and summer programs.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The foregoing facts and recitations contained in the preamble to this resolution are hereby incorporated and adopted by reference as if fully set forth herein.


**Section 2:** The City of Hialeah, Florida hereby accepts and approves the renewal of the Florida's Twenty-First (21<sup>st</sup>) Century Community Learning Centers Grant to fund summer programs operating out of two 21<sup>st</sup> Century Community Learning Centers sites, for students from grades 6 through 12, in the amount of \$422,274.00 for the fourth year of funding commencing on August 1, 2017 and ending on July 31, 2018, ratifies the Grant Agreement, and further authorizes the Mayor or his designee to execute any and all agreements, documents and subcontracts in furtherance thereof.




