

RESOLUTION NO. 2017-087

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO ENTER INTO A PROFESSIONAL SERVICES AGREEMENT WITH ARTS FOR LEARNING/MIAMI, INC. TO DEVELOP AND PROVIDE AFTER-SCHOOL RESEARCH-BASED VISUAL AND PERFORMING ARTS INTEGRATED PROGRAMING AT TEN SITES DURING THE 2017-2018 SCHOOL YEAR, FOR A TERM OF ONE YEAR, COMMENCING ON AUGUST 1, 2017 AND ENDING ON JULY 31, 2018, IN AN AMOUNT NOT TO EXCEED \$21,840.00, IN SUBSTANTIAL CONFORMITY WITH THE AGREEMENT ATTACHED HERETO AND MADE A PART HEREOF AS EXHIBIT "1".

WHEREAS, pursuant to Hialeah, Fla., Resolution No. 2017-043 (May 9, 2017), the Mayor and the City Council amended Hialeah, Fla., Resolution No. 2016-72 (August 18, 2016), which accepted a grant award from the Children's Trust in the amount of \$1,055,718.00 for one year commencing on August 1, 2016 through July 31, 2017, and authorized the Mayor and the City Clerk, on behalf of the City, to execute Amendment No. 1 to the Grant Agreement to reflect the reduction of the funding amount from \$1,055,718.00 to \$905,998.00;

WHEREAS, Arts for Learning/Miami, Inc. will provide the City with after-school research-based visual and performing arts integrated programming at ten (10) sites during the 2017-2018 school year in connection with the City of Hialeah's Education & Community Services Creative Learning and Play program as detailed in the Agreement;


WHEREAS, the City, having investigated the qualifications of the Arts for Learning/Miami, Inc. to perform the all the work necessary to fully carry out its obligations and responsibilities under the Agreement and found Arts for Learning/Miami, Inc. to be qualified and competent; and

WHEREAS, the City of Hialeah finds it in the best interest if he health, safety and welfare of the community to execute this Agreement to benefit students with quality afterschool and summer programs.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The City of Hialeah, Florida hereby authorizes the Mayor and the City Clerk, as attesting witness, on behalf of the City, to enter into a professional services agreement with Arts For Learning/Miami, Inc., a Florida Corporation, to develop and provide after-school research-based visual and performing arts integrated programming at ten sites during the 2017-2018 school year, for a term of one year, commencing on August 1, 2017 and ending on July 31, 2018, in an amount not to exceed \$21,800.00, in substantial conformity with the Agreement attached hereto and made a part hereof as Exhibit "1".
