RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA APPROVING THE CO-DESIGNATION OF THAT PORTION OF WEST 79TH STREET, BETWEEN WEST 10TH AVENUE AND WEST 12TH AVENUE, IN HIALEAH, FLORIDA, PRESENTLY UNNAMED, AS "DANNY PEREZ WAY", IN HONOR AND MEMORY OF THE OUTSTANDING COMMUNITY SERVICE AND DEDICATION OF DANNY PEREZ TO THE CITY OF HIALEAH AND ITS RESIDENTS, WITH THE COST OF SIGNAGE TO BE PAID BY THE CITY.

WHEREAS, born and raised in Miami, Florida, Danny Perez (May 29, 1973 – March 12, 2010);

WHEREAS, as a proud Trojan, Danny graduated in 1992 from Hialeah-Miami Lakes Senior High School;

WHEREAS, throughout his adulthood years, Danny Perez participated in the Special Olympics and other athletic competitions earning many prestigious awards in cycling, power lifting, and basketball;

WHEREAS, Danny Perez dedicated his post high school years to the City of Hialeah and its community, coaching the Hialeah-Miami Lakes Senior High School football, basketball and baseball teams and volunteering with various community organizations and the City of Hialeah Parks and Recreation Department;

WHEREAS, in 2004, Channel 6 (WTVJ) featured a special segment on Danny Perez's outstanding work and commitment to the Hialeah-Miami Lakes Senior High School football team;

WHEREAS, Danny Perez's impressive work with the community was recognized by Miami-Dade County and the City of Hialeah when he was awarded the Inspirational Athlete of the Year in 2008;


WHEREAS, the co-designation of that portion of West 79th Street, between West 10th Avenue and West 12th Avenue, in Hialeah, Florida, presently unnamed, as "DANNY PEREZ WAY", is in honor and memory of the outstanding community service and dedication of Danny Perez; and

WHEREAS, on February 22, 2016, the Historic Preservation Board recommended approval of the co-designation of that portion of West 79th Street, between West 8th Avenue and West 12th Avenue in Hialeah, Florida, as "Danny Perez Way".

THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The portion of West 79th Street, between West 10th Avenue and West 12th Avenue, in Hialeah, Florida, presently unnamed, is hereby co-designated as "Danny Perez Way" and shall be known as such from this day forward, with the costs of signage to be paid by the City.


