

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE TOTALING AN AMOUNT NOT TO EXCEED \$32,960.00 FROM THE LAW ENFORCEMENT TRUST FUND - *FEDERAL*, TO PURCHASE 320 STREAMLIGHT TLR 1 HL WEAPON LIGHTS FOR THE HIALEAH POLICE DEPARTMENT, FROM LOU'S POLICE DISTRIBUTOR, INC., THE LOWEST QUOTE VENDOR, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE.

**WHEREAS**, the Hialeah Police Department responds to civil unrest and other dangerous incidents; and

**WHEREAS**, firearms and handgun accessories are used by the Hialeah Police Department to respond to these situations and to protect public safety; and

**WHEREAS**, pursuant to Hialeah, Fla. Resolution 15-131 (October 13, 2015), the City authorized the Hialeah Police Department to purchase and provide City-issued uniform firearms to its officers; and

**WHEREAS**, the Hialeah Police Department desires to purchase 320 Streamlight TLR 1 HL Weapon lights to utilize as a handgun accessory which will enhance and accommodate the specific handguns authorized for purchase; and

**WHEREAS**, it is in the best interests of the health, safety, and welfare of the citizens of Hialeah and Miami-Dade County for the officers of the Hialeah Police Department to train with and utilize this handgun accessory; and

**WHEREAS**, Lou's Police Distributor's, Inc. is the lowest quoted vendor for the firearms and related accessories; and


**WHEREAS**, the funds to cover these necessary and legitimate expenses are available in the Law Enforcement Trust Fund – *Federal*; and

**WHEREAS**, the Chief of Police has recommended adoption of this resolution and determined that the proposed expenditure complies with the *Guide to Equitable Sharing*; and

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:


**Section 1.** The Mayor and the City Council of the City of Hialeah, Florida, approve the expenditure of an amount not to exceed \$32,960.00 from the Law Enforcement Trust Fund - *Federal*, to purchase 320 Streamlight TLR 1 HL Weapon lights from Lou's Police Distributor, the lowest quoted vendor, upon such costs having been approved by the Chief of Police.


