RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING THE TRANSFER OF UNENCUMBERED APPROPRIATION BALANCE OR A PORTION THEREOF BETWEEN CLASSIFICATIONS OF EXPENDITURES WITHIN AN OFFICE OR DEPARTMENT WITHIN THE GENERAL FUND; WITHIN THE SPECIAL REVENUE FUNDS, IN PARTICULAR, STREET TRANSPORTATION FUND, FIRE PREVENTION FUND, FIRE RESCUE FUND, CHILDREN'S TRUST GRANT FUND, URBAN AREA SECURITY GRANT FUND, CITY SURTAX-HIALEAH CIRCULATOR FUND, ECS & LIBRARY GRANTS FUND, BUILDING FUND, AND WITHIN ENTERPRISE FUNDS, IN PARTICULAR, PUBLIC WORKS FUND-SOLID WASTE, PUBLIC WORKS FUND-WATER & SEWER AND STORMWATER FUND AS SUMMARIZED AND ITEMIZED IN THE SCHEDULE ATTACHES AS EXHIBIT "1B" AND MADE A PART HEREOF.


**WHEREAS**, the City Administration, by and through its Office of Management and Budget, based on actual experience during the first six-months of Fiscal Year 2015-2016, requests that certain line item adjustments be approved by the City of Hialeah with the understanding that the net effect of all adjustment will not increase or decrease the budget of the General Fund and the budgets of designated Special Revenue Funds and Enterprise Funds of the City.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1**: The City of Hialeah, Florida hereby authorize the transfer of unencumbered appropriation balances or a portion thereof between classifications of expenditures within one office or department within the General Fund; within the Special Revenue Funds, in particular, Streets Transportation Fund, Fire Prevention Fund, Fire Rescue Fund


Children's Trust Grant Fund, Urban Area Security Grant Fund, CITT Surtax-Hialeah Circulator Fund, ECS & Library Grants Fund, and Building Fund; and within the Enterprise Funds, in particular, Public Works-Solid Waste Fund, Public Works-Water & Sewer and Stormwater Utility Fund, as summarized and itemized in the schedule attached as Exhibit "1B" and made a part hereof.
