

RESOLUTION NO. 2021-152

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE IN AN AMOUNT NOT TO EXCEED \$15,500.00 FROM THE LAW ENFORCEMENT TRUST FUND-*STATE* FOR THE PURCHASE OF ONE (1) POLICE SERVICE CANINE FOR THE HIALEAH POLICE DEPARTMENT CANINE UNIT FROM METRO DADE K-9 SERVICES, LOWEST QUOTED VENDOR, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Hialeah Police Department Canine Unit has a need to replace one (1) police canine to be used in the field as one (1) police canine with the Department has been retired; and

WHEREAS, a canine is needed to physically apprehend subjects, detect explosives, assist conducting searches of explosive materials near building exteriors, parking lots, office areas, vehicles, packages and persons in and around public building facilities; and

WHEREAS, a canine is needed to provide a strong visible and psychological deterrent against criminal and terrorist threats; and

WHEREAS, the Hialeah Police Department seeks to purchase one (1) canine from Metro-Dade K-9 services, the lowest quoted vendor; and

WHEREAS, Metro-Dade K-9 services is an active corporation in good standing in the state of Florida and licensed by the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) and Drug Enforcement Administration (DEA); and

WHEREAS, the cost of one (1) Police Service Canine from Metro-Dade K-9 Services is \$15,500, see "Exhibit 1" attached hereto, and

WHEREAS, funding for this project will be from account 105.1000.521.640 Law Enforcement Trust Fund-*Federal*; and

WHEREAS, Section 932.7055, Fla. Stat. (2018), the Florida Contraband and Forfeiture Act, authorizes the expenditure of Law Enforcement Trust Funds-*State* for this purpose and the funds are available in the Law Enforcement Trust Fund-*State* account for the Police Department; and

WHEREAS, the Chief of Police of the Hialeah Police Department has recommended adoption of this resolution and determined that the proposed expenditure complies with the Florida Contraband Forfeiture Act, and all applicable rules, regulations and guidelines governing the expenditure of Law Enforcement Trust Fund-*State*; and

WHEREAS, the City finds the expenditure is in the public interest;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:



Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby approves the expenditure of an amount not exceeding \$15,500.00 from the Law Enforcement Trust Fund-*State* for the purchase of one (1) police service canine from Metro-Dade K-9 Services, lowest quoted vendor, upon such costs having been approved by the Chief of Police of the Hialeah Police Department having specifications and pursuant to the terms and conditions as set forth in "Exhibit 1."

Section 3: This resolution shall become effective when approved by majority vote of the City Council and signed by the Mayor or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.





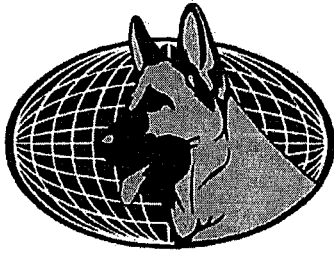

If the dog is deemed unsatisfactory following this examination, "METRO" shall provide a replacement dog to be chosen by "Hialeah Police Department". A replacement dog shall be provided within 30 days of the rejection of the original dog. "METRO" guarantees that the police service dog is in overall good health and will be free from parasites. The teeth have been checked and approved by "Hialeah Police Department". METRO guarantees the health of the police service dog for a period of (6) months for health and performance in accordance with the terms of the Warranty as follows: "METRO" agrees that the (6) months warranty shall apply to each and every dog provided to "Hialeah Police Department", and the (6) month warranty period shall begin when canine has been surrendered and/or delivered to "Hialeah Police Department". The 6 months health is for congenital and hereditary diseases only. The (6) month warranty on performance is contingent upon "Hialeah Police Department" providing complete training records showing the dog has been worked throughout the period of the 6 months and appropriate steps have been taken to ensure that his/her performance is adequate.
