

RESOLUTION NO. 2016-62

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING A PROFESSIONAL SERVICES AGREEMENT WITH GIVING TREE MUSIC, INC. TO PROVIDE CLASSROOM INSTRUCTION TO THE PARTICIPANTS OF THE CREATIVE LEARNING AND PLAY SUMMER PROGRAM, TOGETHER WITH SUPPLIES, FOR A TERM COMMENCING ON JUNE 1, 2016 AND ENDING ON JULY 31, 2016, IN AN AMOUNT NOT TO EXCEED \$15,000, AND AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO EXECUTE THE PROFESSIONAL SERVICES AGREEMENT ATTACHED HERETO IN SUBSTANTIAL FORM, AND MADE A PART HEREOF AS EXHIBIT "1".

WHEREAS, the City of Hialeah is continuously searching for new ways to support the maintenance and growth of its educational programs and expand services to the community;

WHEREAS, pursuant to Hialeah, Fla., Resolution 2015-51 (April 14, 2015) the City Council authorized the Mayor to accept a grant through the Miami-Dade County Children's Trust in the amount of \$1,167,066.00 for aftercare and tutoring programs and to enter into any agreements in furtherance thereof; and

WHEREAS, the City having investigated the qualifications of Giving Tree Music, Inc. (hereafter referred to as "Provider") to perform the work and found the Provider to be qualified and competent; and


WHEREAS, the City agrees to enter into this professional services agreement with the Provider and the Provider agrees to accept engagement under the terms and conditions included in the professional services agreement attached hereto in substantial form, and made a part hereof as Exhibit "1";

WHEREAS, the City of Hialeah finds that it is in the best interest of the health, safety and welfare of the community to enter into this professional services agreement with the Provider to provide participants of the Creative Learning and Play Summer Program with quality classroom instruction and supplies, ensuring their academic success.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:


Section 1: The City of Hialeah, Florida hereby approves a professional services agreement with Giving Tree Music, Inc. to provide classroom instruction to the participants of the Creative Learning and Play Summer Program, together with supplies, for a term commencing on June 1, 2016 and ending on July 31, 2016, in an amount not to exceed \$15,000.00, and authorizing the Mayor and the City Clerk, as attesting witness, on behalf of the City, to execute the professional services agreement attached hereto in substantial form, and made a part hereof as Exhibit "1". The City Council hereby approves, adopts and ratifies all prior actions, approvals, payments and other actions whatsoever taken by the Mayor, or his designee, on behalf of the City in the performance of this agreement.




