

RESOLUTION NO. 2016-64

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING A PROFESSIONAL SERVICES AGREEMENT WITH COMMON THREADS, INC. TO PROVIDE DYNAMIC HANDS ON COOKING CLASSES TO STUDENTS IN GRADES 6TH TO 12TH, COMMENCING ON JUNE 15, 2016 AND ENDING ON JULY 31, 2016, IN AN AMOUNT NOT TO EXCEED \$4,008.00, AND AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO EXECUTE THE PROFESSIONAL SERVICES AGREEMENT ATTACHED HERETO IN SUBSTANTIAL FORM, AND MADE A PART HEREOF AS EXHIBIT "1".

WHEREAS, the City of Hialeah is continuously searching for new ways to support the maintenance and growth of its educational programs and expand services to the community;

WHEREAS, pursuant to Hialeah, Fla., Resolution 2015-19 (Feb. 10, 2015) the City Council authorized the Mayor to accept a grant from Florida Department of Education in the amount of \$699,922.00 to fund aftercare and tutoring programs and to enter into all agreements in furtherance thereof;

WHEREAS, the Florida Department of Education has awarded the City for year two of the Florida's Twenty-First (21st) Century Soaring Beyond Expectations grant, an award in the amount of \$428,928.00;

WHEREAS, the City having investigated the qualifications of Common Threads, Inc. (hereafter referred as to "Provider") to perform the work and found the Provider to be qualified and competent;

WHEREAS, the City agrees to enter into this professional services agreement with the Provider and the Provider agrees to accept engagement under the terms and conditions included in the professional services agreement attached hereto in substantial form, and made a part hereof as Exhibit "1"; and


WHEREAS, the City of Hialeah finds that it is in the best interest of the health, safety and welfare of the community to enter into this professional services agreement with the Provider to provide dynamic hands on cooking classes to students to promote healthy nutrition and support public health.




Section 1: The City of Hialeah, Florida hereby approves a professional services agreement with Common Threads, Inc. to provide dynamic hands on cooking classes to students in grades 6th to 12th, commencing on June 15, 2016 and ending on July 31, 2016, in an amount not to exceed \$4,008.00, and authorizes the Mayor and the City Clerk, as attesting witness, on behalf of the City, to execute the professional services agreement attached hereto in substantial form, and made a part hereof as Exhibit "1". The City Council hereby approves, adopts and ratifies all prior actions, approvals, payments and other actions whatsoever taken by the Mayor, or his designee, on behalf of the City in the performance of this agreement.
