

RESOLUTION NO. 2016-98

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA APPROVING THE PURCHASE OF A 2016 THIRTY-TWO FOOT EL DORADO EZ RIDER II PASSENGER BUS, IN THE TOTAL AMOUNT OF \$340,400.00, FROM EL DORADO NATIONAL-CALIFORNIA, INC.; AUTHORIZING THE MAYOR AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO EXECUTE A PURCHASE CONTRACT AND ALL OTHER NECESSARY DOCUMENTS IN FURTHERANCE HEREOF IN A FORM ACCEPTABLE TO THE CITY ATTORNEY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Hialeah, a municipal corporation of the State of Florida, has authority under the Constitution and the laws of the State of Florida to purchase and acquire a 2016 thirty-two (32) feet El Dorado EZ Rider II bus as described in the product specifications, attached hereto as Exhibit "1"; and

WHEREAS, the City is purchasing the passenger bus on substantially similar terms to a competitively bid contract awarded to El Dorado National-California, Inc. ("Vendor") by the Houston-Galveston Area Council in Houston, Texas ("HGAC Contract") for the purchase of Buses-Shuttle, Transit, Trams & Other Specialty Buses offered by Vendor; and

WHEREAS, the Council finds that the purchase of the passenger bus based upon the terms and conditions of the HGAC Contract is exempt from competitive bidding pursuant to Hialeah Code Section 2-818; and

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this ordinance are hereby adopted and incorporated by reference as if fully set forth herein.


Section 2: The City of Hialeah, Florida hereby approves the purchase of a 2016 thirty-two foot El Dorado EZ Rider II passenger bus, in the total amount of \$340,400.00, from El Dorado National-California, Inc. and authorizes the Mayor and the City Clerk, as attesting

witness, on behalf of the City, to execute a purchase contract and all other necessary documents in furtherance hereof in a form acceptable to the City Attorney.

Section 3: Effective Date.






