

**RESOLUTION NO. 2016-101**

RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE CITY OF HIALEAH'S STATE HOUSING INITIATIVES PARTNERSHIP (SHIP) ANNUAL REPORT FOR FISCAL YEARS 2013-2014, 2014-2015, AND 2015-2016, ATTACHED HERETO AND MADE A PART HEREOF AS EXHIBIT "1"; AUTHORIZING THE SUBMISSION OF THE CITY OF HIALEAH'S STATE HOUSING INITIATIVES PARTNERSHIP (SHIP) ANNUAL REPORT FOR FISCAL YEARS 2013-2014, 2014-2015, AND 2015-2016 TO THE STATE HOUSING INITIATIVES PARTNERSHIP (SHIP) PROGRAM; AND PROVIDING FOR AN EFFECTIVE DATE .

**WHEREAS**, the State of Florida enacted the William E. Sadowski Affordable Housing Act, Chapter 92-317 of Florida Sessions Laws, allocating a portion of documentary stamp taxes on deeds to local governments for the development and maintenance of affordable housing;

**WHEREAS**, the State Housing Initiatives Partnership (SHIP) Act, Sections 420.907-420.9079, Florida Statutes (2016), require an eligible municipality to submit each year a report of its affordable housing programs and accomplishments of the preceding year;

**WHEREAS**, pursuant to Section 420.9075(10) of the Florida Statutes (2016), transmittal of the annual report certifies that the local housing incentive strategies, or, if applicable, the local housing incentive plan, have been implemented or are in the process of being implemented pursuant to the adopted schedule for implementation; and

**WHEREAS**, the City of Hialeah has completed the State Housing Initiatives Partnership Annual Report for submission to the State Housing Initiatives Partnership (SHIP) Program in compliance with the requirements as set forth in the State Housing Initiatives Partnership (SHIP) Act and the applicable Florida Statutes.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The foregoing facts and recitations contained in the preamble to this Resolution are hereby incorporated and adopted by reference as if fully set forth herein.

**Section 2:** The Mayor and City Council of the City of Hialeah hereby approve the City of Hialeah's State Housing Initiatives Partnership (SHIP) annual report for fiscal years 2013-2014, 2014-2015, and 2015-2016, attached hereto and made a part hereof as Exhibit "1"; and authorizes the submission of the City of Hialeah's State Housing Initiatives Partnership (SHIP) annual report for fiscal years 2013-2014, 2014-2015, and 2015-2016 to the State Housing Initiatives Partnership (SHIP) Program.

**Section 3:** This resolution shall become effective when approved by majority vote of the City Council and signed by the Mayor or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.
