RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING A BUDGET AMENDMENT TO THE CITY OF HIALEAH ACTION PLAN FOR FISCAL YEAR 2010-2011, 2011-2012, 2012-2013, 2013-2014, 2015-2016 AND AUTHORIZING THE MAYOR OR HIS DESGINEE TO EXECUTE AND IMPLEMENT A BUDGET AMENDMENT TO THE CITY OF HIALEAH ACTION PLAN FOR FISCAL YEARS, 2010-2011, 2011-2012, 2012-2013, 2013-2014, 2015-2016 TO REALLOCATE UNEXPENDED FUNDS OF FISCAL YEARS 2010 THROUGH 2015 OF \$2,408,362.00 UNDER THE HOME INVESTMENT PARTNERSHIP ACT PROGRAM TO FUND APPROVED HOME PROJECTS DURING PROGRAM YEAR 2016-2017 AND AUTHORIZING THE MAYOR OR HIS DESGINEE TO EXECUTE ANY AND ALL AMENDMENTS, CERTIFICATIONS AND ASSURANCES IN FURTHERANCE OF THE PROGRAM UNDER US HUD REGULATIONS.

WHEREAS, the City of Hialeah is an entitlement community and receives an annual allocation of funds from the United States Department of Housing and Urban Development under the Community Planning Development (CPD) Entitlement programs; and

WHEREAS, the City of Hialeah has been recently allocated unexpended funds for fiscal year 2010 through 2015 in the amount of \$2,408,362.00 under the Home Investment Partnership Act Program; and

WHEREAS, the regulations governing the use of these funds require an amendment to the 2010-2011, 2011-2012, 2012-2013, 2013-2014, and 2015-2016 annual action plan;

WHEREAS, the purpose of this amendment is to incorporate program funds that will benefit low and moderate income persons in the City; and

WHEREAS, the City complied with the thirty day required comment period for citizen participation.

NOW THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

SECTION 1: The City of Hialeah hereby authorizes the Mayor or his designee to implement a substantial budget amendment to the City of Hialeah Action Plan for fiscal years



2010-2011, 2011-2012, 2012-2013, 2013-2014, 2015-2016 to reallocate the unexpended funds in fiscal years 2010 through 2015 for \$2,408,362.00 to fund approved programs under the Home Investment Partnership Act Programs for 2016-2017.

SECTION 2: The City of Hialeah hereby further authorizes the Mayor or his designee to execute any and all amendments, certifications and assurances in furtherance of the program in accordance with US HUD regulations.




