RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA ACCEPTING THE GRANT AWARD FROM THE MIAMI-DADE COUNTY DEPARTMENT OF CULTURAL AFFAIRS UNDER THE TARGETED INITIATIVES GRANTS PROGRAM AND AUTHORIZING THE MAYOR AND THE ACTING DEPUTY CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO ENTER INTO A GRANT AGREEMENT COMMENCING ON OCTOBER 1, 2014 AND ENDING SEPTEMBER 30, 2015, IN FURTHERANCE THEREOF, IN A FORM ACCEPTABLE TO THE CITY ATTORNEY.

WHEREAS, the Miami-Dade Department of Cultural Affairs, under its Targeted Initiatives Grants Program, notified the City of Hialeah on January 12, 2015 of a grant awarded to the City in the amount of \$30,000 to support the City's Art on Palm, July 4th and Hispanic Heritage Month Series event, and other special events.

WHEREAS, pursuant to Hialeah, Fla., Resolution 14-14 (Jan. 28, 2014), the City entered into a one year grant agreement, in the amount of \$30,000, with the Miami-Dade County Department of Cultural Affairs, under the Targeted Initiatives Grants Program, to support the City's Art on Palm, July 4th and Hispanic Heritage Month Series events; and

WHEREAS, the City of Hialeah finds it in the best interest of the community to accept the grant award from the Miami-Dade County Department of Cultural Affairs.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:


Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby incorporated and adopted by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby accepts the Grant Award from the Miami-Dade County Department of Cultural Affairs, in the amount of \$30,000 in connection

with the Targeted Initiative Grant Program to support the Art on Palm, July 4th and Hispanic Heritage Month Series events, and other special events.

Section 3: The City of Hialeah, Florida hereby authorizes the Mayor and the Acting Deputy City Clerk, as attesting witness, on behalf of the City, to enter into a Grant Agreement commencing on October 1, 2014 and ending on September 30, 2015 in furtherance thereof, in a form acceptable to the City Attorney.






