

RESOLUTION NO. 2022-087

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, ADOPTING THE CITY'S ONE-YEAR ACTION PLAN FOR FEDERAL FUNDS FOR FISCAL YEAR 2022, WHICH INCLUDES THE ADMINISTRATIVE BUDGETS FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM IN THE AMOUNT OF \$2,650,569.00; THE HOME INVESTMENT PARTNERSHIPS PROGRAM IN THE AMOUNT OF \$1,687,182.00; THE EMERGENCY SOLUTIONS GRANT IN THE AMOUNT OF \$232,266.00; AUTHORIZING THE USE OF FISCAL YEAR 2021 EMERGENCY SOLUTIONS GRANT FUNDS FOR THE CREATION OF HOMELESS OUTREACH SERVICES; AND FURTHER AUTHORIZING: (1) THE EXECUTION OF ALL APPLICABLE DOCUMENTS RELATED TO THE APPROPRIATION AND ALLOCATION OF THESE PROGRAM FUNDS; (2) SUBMISSION OF THE ONE-YEAR ACTION PLAN TO HOUSING AND URBAN DEVELOPMENT; (3) AMEND THE CONSOLIDATED PLAN TO REFLECT THE ACTIVITIES WITHIN THE ACTION PLAN; AND FURTHER AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE INTRADEPARTMENTAL AGREEMENTS FOR SUB-RECIPIENTS OF EMERGENCY SERVICES GRANT AND COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS.

WHEREAS, the City is an entitlement recipient of Federal formula grants from the U.S. Department of Housing and Urban Development ("HUD") for the following programs: Community Development Block Grant ("CDBG"), HOME Investment Partnership ("HOME") and Emergency Solutions Grant ("ESG"); and

WHEREAS, HUD awarded the City the following Fiscal Year 2022 funds: \$2,650,569.00 in CDBG funds; \$1,687,182.00 in HOME funds; and \$232,266.00 in ESG funds; and

WHEREAS, the City is entitled to utilize a percentage of funds from each program for administrative use to include monitoring and compliance of federal funds;

WHEREAS, the amount available for administrative use for each fund is: \$530,113.80. for CDBG; \$168,718.20. for HOME; and \$17,419.95. for ESG; and

WHEREAS, the City had been awarded \$241,553.00 in Fiscal Year 2021 ESG funds that had remained uncommitted and are hereby proposed for the creation of homeless outreach services to ensure the City's homeless are provided with engagement and emergency shelter; and

WHEREAS, HUD requires a 30-day comment period which commenced on June 17, 2022 and ends on July 18, 2022; and

WHEREAS, the City's Consolidated Plan for Fiscal Year 2020-2024 will be updated to reflect the activities proposed herein; and

WHEREAS, the City is required to submit its Action Plan and updated Consolidated Plan to HUD no later than August 16, 2022.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby approves the use of administrative funds as allowed by the CDBG, HOME and ESG programs.

Section 3: The City hereby authorizes the Mayor, or his designee, and the City Clerk, as an attesting witness, to execute any and all agreements required in furtherance of this Resolution.


Section 4: This Resolution shall become effective when passed by the City Council and signed by the Mayor or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.




