

**RESOLUTION NO. 2015-42**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, NAMING THE CULTURAL HERITAGE, EDUCATION AND PERFORMING ARTS PARK, LOCATED AT THE INTERSECTION OF WEST 76<sup>TH</sup> STREET, BETWEEN WEST 17<sup>TH</sup> AVENUE AND WEST 18<sup>TH</sup> AVENUE, HIALEAH, FLORIDA, "GARDEN OF THE ARTS", AND AMENDING THE CITY OF HIALEAH'S MASTER PLAN AND INTERLOCAL AGREEMENT AND ANY OTHER DOCUMENTS REFERENCING THE CULTURAL PARK TO REFLECT THIS NAMING.

**WHEREAS**, the City of Hialeah wishes to name the Cultural Heritage Education and Performing Arts Park, located at the intersection of West 76<sup>th</sup> Street, between West 17<sup>th</sup> Avenue and West 18<sup>th</sup> Avenue, "GARDEN OF THE ARTS"; and

**WHEREAS**, in addition to the typical features of a park, such as walking trails, benches, and lush landscaping, this facility also offers multicultural educational and performing arts opportunities and activities to children and adults in our community; and

**WHEREAS**, the City's Master Plan for this park, which was adopted by City of Hialeah Resolution No. 2015-11, and the interlocal agreement between the City of Hialeah and Miami-Dade County, as well as any other documents referencing the park, are hereby amended to reflect this naming; and


**WHEREAS**, the Hialeah Historic Preservation Board has recommended approval of this resolution.

THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The Cultural Heritage, Education and Performing Arts Park located at the intersection of West 76<sup>th</sup> Street, between West 17<sup>th</sup> Avenue and West 18<sup>th</sup> Avenue, Hialeah, Florida, is hereby designated as "GARDEN OF THE ARTS," and shall be known as such from this day forward.


**Section 2:** The City's Master Plan and interlocal agreement, as well as any other documents referencing this park are hereby amended to reflect this naming.


