

RESOLUTION NO.: 2015-44

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE TOTALING AN AMOUNT NOT TO EXCEED \$15,226.12 FROM THE LAW ENFORCEMENT TRUST FUND - *FEDERAL*, FOR THE PURCHASE OF FOURTEEN (14) K-9 TRANSPORTING SYSTEMS FROM AMERICAN ALUMINUM ACCESSORIES, LOWEST QUOTED VENDOR, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE.

WHEREAS, the Hialeah Police Department is requesting to purchase fourteen (14) K-9 transporting systems from American Aluminum Accessories, Inc., lowest quoted vendor, for installation in the vehicles assigned to the Department's K-9 unit; and

WHEREAS, the Hialeah Police Department deploys specialized police canines for the apprehension of subjects and the locating of concealed contraband and explosive devices; and

WHEREAS, the transporting systems that are currently installed in the vehicles assigned to the Department's K-9 unit are older and are showing signs of wear and tear; and

WHEREAS, to facilitate the safe and secure transportation of these canines it is necessary to purchase fourteen K-9 transporting systems; and

WHEREAS, the funds to cover these necessary and legitimate expenses are available in the Law Enforcement Trust Fund - *Federal*; and

WHEREAS, the Chief of Police has recommended adoption of this resolution and determined that the proposed expenditure complies with the provisions of *Guide To Equitable Sharing*.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1. The Mayor and the City Council of the City of Hialeah, Florida, approve the expenditure of an amount not to exceed \$15,226.12 from the Law Enforcement

Trust Fund – *Federal*, for the purchase of fourteen (14) K-9 transporting systems from American Aluminum Accessories, Inc., lowest quoted vendor, upon such costs having been approved by the Chief of Police.

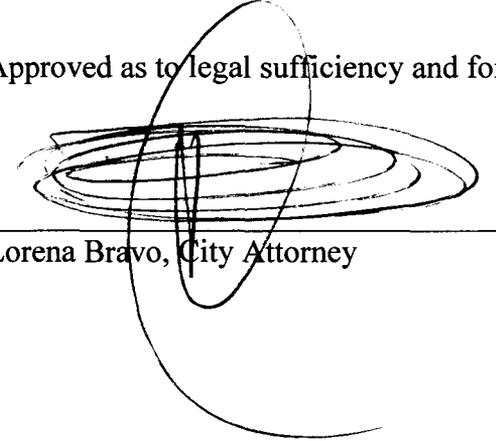
