

RESOLUTION NO. 2015-49

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA APPROVING THE CO-DESIGNATION OF A PORTION OF EAST 5TH AVENUE, FROM EAST 50TH TO EAST 52ND STREET, HIALEAH, FLORIDA, AS "DOMINGUEZ AND MARGARITA WAY", IN RECOGNITION OF ORLANDO DOMINGUEZ'S DEDICATION TO THE BETTERMENT OF THE CITY OF HIALEAH, WITH THE COST OF SIGNAGE TO BE PAID BY THE CITY.

WHEREAS, the co-designation of that portion of East 5th Avenue, from East 50th to East 52nd Street, Hialeah, Florida, as "DOMINGUEZ AND MARGARITA WAY", presently unnamed, is in recognition of Orlando Dominguez's dedication to the betterment of his community, with the cost of signage to be paid by the City; and

WHEREAS, Orlando Dominguez and his wife, Margarita Dominguez, were born in Havana, Cuba, and moved to Hialeah, Florida in 1971 with their three daughters; and

WHEREAS, Orlando and Margarita Dominguez resided for thirty four years at 5060 East 5th Avenue, Hialeah, Florida.

WHEREAS, seeking a better future for himself and his family, Orlando Dominguez worked diligently as a residential painter and driveway and roof pressure cleaner for over forty years; and

WHEREAS, when he was not working and spending time with his family, Orlando Dominguez became an active member of his beloved Hialeah community, becoming an active member of the City of Hialeah Chamber of Commerce in 1973, and then serving as Director of the Chamber of Commerce for over 30 years; and

WHEREAS, during his time with the Chamber of Commerce, Orlando Dominguez participated in and supported the City of Hialeah's local political initiatives that lead to great growth for the City, and always served the best interests of its residents; and

WHEREAS, the Historic Preservation Board has recommended approval of this resolution.

THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The portion of East 5th Avenue, from East 50th to East 52nd Street, Hialeah, Florida, presently unnamed, is hereby co-designated as "DOMINGUEZ AND

MARGARITA WAY", and shall be known as such from this day forward, with the costs of signage to be paid by the applicant.




