RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA ACCEPTING A GRANT, BY AND THROUGH THE CITY OF HIALEAH POLICE DEPARTMENT, AWARDED BY THE FLORIDA DEPARTMENT OF HIGHWAY SAFETY & MOTOR VEHICLES ("DHSMV") UNDER THE FISCAL YEAR 2014 SaDIP FUNDING AWARD AND TECHNICAL ASSISTANCE GRANT PROGRAM, IN THE TOTAL AMOUNT OF \$45,000.00, TO PURCHASE PORTABLE COMPUTING DEVICES (PCD) AND MOUNTING HARDWARE AND THEREBY ENABLE THE CITY'S POLICE DEPARTMENT TO INCREASE E-CRASH REPORTING OF COMMERCIAL MOTOR VEHICLES ("CMV") TO DHSMV, AND FURTHER AUTHORIZING THE CHIEF OF POLICE AND THE CITY CLERK, AS ATTESTING WITNESS, ON BEHALF OF THE CITY, TO EXECUTE THE GRANT AGREEMENT AND ANY OTHER DOCUMENTS IN FURTHERANCE THEREOF.

WHEREAS, the City is eligible to receive a grant award in the amount of \$45,000.00 through the Department of Highway Safety & Motor Vehicle, under the Fiscal Year 2014 SaDIP Funding Award Safety Data Improvement Project Grant (SaDIP); and

WHEREAS, it is in the best interest of the welfare of the community to accept this grant award to increase and improve the City of Hialeah Police Department's e-crash reporting of commercial motor vehicles system ensuring outstanding service, rapid response and security.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA; THAT:

Section 1: The Mayor and City Council of the City of Hialeah, Florida hereby accepts, by and through the City of Hialeah Police Department, a grant from the Florida Department of Highway Safety & Motor Vehicles ("DHSMV") under the Fiscal Year 2014 SaDIP Funding Award and Technical Assistance Grant Program, in the total amount of

\$45,000.00, to purchase portable computing devices (PCD) and mounting hardware and thereby enable the City's Police Department to increase e-crash reporting of commercial motor vehicles ("CMV") to DHSMV, and further authorize the Chief of Police and the City Clerk, as attesting witness, on behalf of the City, to execute the grant agreement and any other document in furtherance thereof.


