

RESOLUTION NO.: 2015-71

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, APPROVING THE EXPENDITURE TOTALING AN AMOUNT NOT TO EXCEED FIFTEEN THOUSAND THREE HUNDRED AND TWELVE DOLLARS AND FIFTY-SIX CENTS (\$15,312.56) FROM THE LAW ENFORCEMENT TRUST FUND - *FEDERAL*, TO PURCHASE AN IDENTIFICATION CARD PRINTER AND RELATED ACCESSORIES FROM PLASCO, INC., THE LOWEST QUOTED VENDOR, UPON SUCH COSTS HAVING BEEN APPROVED BY THE CHIEF OF POLICE.

**WHEREAS**, the Hialeah Police Department is responsible for issuing identification cards to all City of Hialeah personnel; and

**WHEREAS**, the employees utilize their identification cards when coming in contact with members of the community during their business functions; and

**WHEREAS**, the Hialeah Police Department seeks to protect its municipal identification cards from fraud and counterfeit reproduction that will produce identification cards highly resistant to counterfeiting when printed and encoded; and

**WHEREAS**, to minimize the likelihood of these identification cards falling into the hands of criminals, and to upgrade to a product compatible with the newly upgraded computer system being utilized by the Hialeah Police Department, it is necessary to purchase an identification printer and related accessories that will have overt and covert security features; and

**WHEREAS**, the Hialeah Police Department is requesting authorization to purchase an identification card printer and related accessories from Plasco, the lowest quoted vendor, for a total expenditure not to exceed \$15,312.56; and


**WHEREAS**, the funds to cover these necessary and legitimate expenses are available in the Law Enforcement Trust Fund - *Federal*; and

**WHEREAS**, the Chief of Police has recommended adoption of this resolution and determined that the proposed expenditure complies with the provisions of the *Guide To Equitable Sharing* and all applicable statutes.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:


**Section 1.** The Mayor and the City Council of the City of Hialeah, Florida, approve the expenditure of an amount not to exceed Fifteen Thousand Three Hundred and Twelve dollars and Fifty-six cents (\$15,312.56), from the Law Enforcement Trust Fund –*Federal*, to purchase an Identification Card Printer and related accessories from Plasco, Inc., the lowest quoted vendor, upon such costs having been approved by the Chief of Police.


