

**RESOLUTION NO. 2015-72**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA APPROVING THE FINAL DECISION OF THE PLANNING AND ZONING BOARD, DECISION NO. 15-2 THAT GRANTED ADJUSTMENTS ON PROPERTY LOCATED AT **1252 WEST 78 STREET, HIALEAH, FLORIDA**; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the Planning and Zoning Board, at its regular meeting of April 8, 2015, entered a final decision, Decision No. 15-2, subject to review by the Hialeah City Council;

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The Mayor and the City Council of the City of Hialeah, Florida hereby approve Final Decision No. 15-2 granting an adjustment of 3 feet, more or less, where 7.5 feet are required, to the east side setback, granting an adjustment of 5.2 feet, where 20 feet are required, as to the distance between the main residence and accessory building. The property is located at 1252 West 78 Street, Hialeah, Florida, zoned R-1 (One Family District).

**Section 2:** This resolution shall become effective upon signature of the Mayor of the City of Hialeah, Florida or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.




1. The Planning and Zoning Board adopts the findings of fact contained in the report of the Principal Planner.


