

RESOLUTION NO. 2022-143

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AMENDING THE CITY'S ONE-YEAR ACTION PLAN FOR FEDERAL FUNDS FOR FISCAL YEARS 2021 AND 2022, WHICH INCLUDES THE FISCAL YEAR 2021 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) PROGRAM IN THE AMOUNT OF \$9,131.49, THE FISCAL YEAR 2022 COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG) IN THE AMOUNT OF \$168,355.39, THE FISCAL YEAR 2020 COMMUNITY DEVELOPMENT BLOCK GRANT- CORONAVIRUS (CDBG-CV) IN THE AMOUNT OF \$4,121.00; AUTHORIZING THE FOLLOWING ACTIONS: (1) EXECUTION OF ALL APPLICABLE DOCUMENTS RELATED TO THE APPROPRIATION AND ALLOCATION OF THESE PROGRAM FUNDS, (2) SUBMISSION OF THE AMENDED ONE-YEAR ACTION PLAN TO HUD FOR THE FISCAL YEARS IMPACTED, AND (3) AMENDMENT OF THE CONSOLIDATED PLAN TO REFLECT THE ACTIVITIES WITHIN THE ACTION PLAN; FURTHER AUTHORIZING THE MAYOR, OR HIS DESIGNEE, AND CITY CLERK, AS ATTESTING WITNESS, TO EXECUTE INTRADEPARTMENTAL AGREEMENTS FOR SUB-RECIPIENTS OF THESE FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City is an entitlement recipient of Federal formula grants from the U.S. Department of Housing and Urban Development (HUD) for the following programs: Community Development Block Grant (CDBG), HOME Investment Partnership (HOME) and Emergency Solutions Grant (ESG); and

WHEREAS, HUD awarded the City the following FY 23 funds: \$2,650,569 in CDBG funds; and

WHEREAS, the City is hereby appropriating \$9,131.49 in Fiscal Year 2021 and \$168,355.39 in Fiscal Year 2022 in CDBG Funds for Fire Safety Equipment for the Hialeah Fire Department with additional funds in Fiscal Year 2020 Community Development Block Grant - Coronavirus (CDBG-CV) funds are being re-appropriated in the amount of \$4,121; and

WHEREAS, HUD requires a 30-day comment period which commenced on November 9, 2022 and ended on December 9, 2022; and

WHEREAS, the City's Consolidated Plan for FY 2020-2024 and affected Annual Action Plans will be updated to reflect the activities authorized by this Resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:


Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.

Section 2: The re-appropriation of funds as allowed by the CDBG and CDBG-CV programs in the amounts and to the extend described in the title of this Resolution is hereby approved.

Section 3: The Mayor, or his designee, and the City Clerk as attesting witness, are hereby authorized to execute an any all necessary documents for the appropriation and allocation of program funds as, to submit the amended one-year Action Plan to U.S. HUD, and to amend the consolidated plan to reflect the activities within the Action Plan, as amended.

Section 4: This Resolution shall become effective when passed by the City Council and signed by the Mayor or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.




