

RESOLUTION NO. 2023-008

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, RESPECTFULLY URGE THE FLORIDA LEGISLATURE TO APPROPRIATE FUNDS FOR RIGHT-OF-WAY IMPROVEMENT PROJECTS INCLUDING ROAD WIDENING, STORMWATER INFRASTRUCTURE IMPROVEMENTS, ROAD RECONSTRUCTION, NEW SIDEWALKS MEETING CURRENT ADA STANDARDS, NEW LED STREET LIGHTS, IMPROVED OFFSITE SCHOOL PICKUP/DROP OFF ZONE AND IMPROVED SCHOOL PEDESTRIAN CROSSINGS IN THE AMOUNT OF \$1,980,000 DOLLARS, REPRESENTING 80% OF THE PROJECTS' TOTAL ESTIMATED COST, TO WHICH THE CITY WILL MATCH FUNDING IN AN AMOUNT EQUAL TO NO LESS THAN 20% OF THE TOTAL COSTS OF THE PROJECTS.

WHEREAS, the City of Hialeah respectfully urges the Florida legislature to appropriate funds for various city right-of-way improvements, including road widening, stormwater infrastructure improvements, road reconstruction, new sidewalks meeting current ADA standards, new LED street lights, improved offsite school pickup/drop off zone and improved school pedestrian crossings; and

WHEREAS, the estimated total expenditure for the right-of-way improvements is \$2.25 million dollars; and

WHEREAS, the benefits to the community would be improved level of service for vehicular and pedestrian traffic as well as increased pedestrian safety.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:


Section 1: The Florida Legislature is hereby respectfully urged to appropriate funds to fund the expenditure of certain city right-of-way improvements projects including road widening, stormwater infrastructure improvements, road reconstruction, new sidewalks meeting current

ADA standards, new LED street lights, improved offsite school pickup/drop off zone and improved school pedestrian crossings in the amount of \$1,980,000 dollars, representing 80% of the estimated cost of the projects, to which the City will match funding in an amount equal to no less than 20% of the total costs of the projects.


Section 2: The City of Hialeah, Florida hereby authorizes the Mayor or his designee on behalf of the City to prepare, execute and submit all necessary applications, certifications and documents in furtherance of this funding or appropriations request.

Section 3: The City Clerk is authorized to send a copy of this Resolution as is necessary to accomplish the goal of obtaining funding such other agencies or persons as may be deemed necessary.




