

RESOLUTION OF THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA APPROVING AND RATIFYING A GRANT AGREEMENT BETWEEN THE CITY AND THE UNITED STATES DEPARTMENT OF HOMELAND SECURITY, FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA), FOR A DIRECT AWARD IN THE AMOUNT OF \$436,519.00, WITH A 10% MATCHING REQUIREMENT IN THE AMOUNT OF \$43,651.00, FOR A TOTAL PROJECT COST OF \$480,170.00, UNDER THE FISCAL YEAR 2014 ASSISTANCE TO FIREFIGHTERS GRANT PROGRAM, TO BE UTILIZED FOR THE PURCHASE OF FIREFIGHTING EQUIPMENT.

WHEREAS, the City is eligible to receive a direct award in the amount of \$436,519.00, with a 10% matching requirement in the amount of \$43,651.00, for a total project cost of \$480,170.00, through the United States Department of Homeland Security, Federal Emergency Management Agency (FEMA), under the Fiscal Year 2014 Assistance to Firefighters Grant Program, to be utilized for the purchase of firefighting equipment and wellness; and

WHEREAS, the City completed an application and entered into a grant agreement with the United States Department of Homeland Security, Federal Emergency Management Agency (FEMA), and executed all documents in furtherance of the grant requirements, pursuant to Resolution 2010-45.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA; THAT:

Section 1: The Mayor and City Council of the City of Hialeah, Florida hereby approve and ratify the grant agreement between the City and the United States Department of Homeland Security, Federal Emergency Management Agency (FEMA), under the Fiscal Year 2014 Assistance to Firefighters Grant Program, for the amount of \$436,519.00, with a 10% matching requirement in the amount of \$43,651.00, for a total project cost of \$480,170.00, to be utilized for the purchase of firefighting equipment and wellness.






