

RESOLUTION NO. 2015-157

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA ACCEPTING A GRANT AWARD FROM THE STATE OF FLORIDA DEPARTMENT OF ELDER AFFAIRS, THROUGH ALLIANCE FOR AGING, INC. IN THE AMOUNT OF \$1,150,000.00 TO PROVIDE CONGREGATE MEALS AT SIX SITES THROUGHOUT THE CITY FOR ONE-YEAR COMMENCING ON JULY 1, 2015 AND ENDING ON JUNE 30, 2016; APPROVING AND RATIFYING A LOCAL SERVICES PROGRAM AGREEMENT BETWEEN ALLIANCE FOR AGING, INC., AND THE CITY OF HIALEAH, FLORIDA, EXECUTED BY ANNETTE QUINTANA AS DIRECTOR OF THE GRANTS DEPARTMENT ON BEHALF OF THE CITY OF HIALEAH, A COPY OF WHICH IS ATTACHED HERETO AND MADE A PART HEREOF AS EXHIBIT "1"; AND FURTHER AUTHORIZING THE MAYOR OR HIS DESIGNEE ON BEHALF OF THE CITY TO EXECUTE ALL OTHER NECESSARY DOCUMENTS IN FURTHERANCE THEREOF.

WHEREAS, the City of Hialeah is continuously searching for available grants as a source of funding to support the maintenance and growth of programs benefiting the elderly; and

WHEREAS, the Florida Department of Elder Affairs administers and funds programs, services, and initiatives benefiting the elderly; and

WHEREAS, Alliance for Aging, Inc., which promotes and advocates for the optimal quality of life of the elderly and their families, was designated by the State of Florida as the Area Agency for Miami-Dade and Monroe Counties to fund programs and initiatives benefiting the elderly, administer the programs and services it funds and provide training, technical assistance and support to the contracted agencies; and

WHEREAS, the City of Hialeah has been awarded a grant to provide congregate meals at six sites throughout the City in the amount of \$1,500,000.00; and

WHEREAS, the City desires to enter into a one-year grant agreement with Alliance for Aging, Inc. in furtherance thereof; and

WHEREAS, the City of Hialeah finds it in the best interest of the health, safety and welfare of the community to accept the grant award to benefit its elderly and enter into a new grant agreement accordingly.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: The foregoing facts and recitations contained in the preamble to this resolution are hereby incorporated and adopted by reference as if fully set forth herein.

Section 2: The City of Hialeah, Florida hereby accepts a grant award from the State of Florida Department of Elder Affairs, through Alliance for Aging, Inc. in the amount of \$1,150,000.00 to provide congregate meals at six sites throughout the City for one-year commencing on July 1, 2015 and ending on June 30, 2016.

Section 3: The City of Hialeah, Florida hereby approves and ratifies the Local Services Program Agreement between Alliance for Aging, Inc., and the City of Hialeah, Florida, executed by Annette Quintana as Director for the Grants Department on behalf of the City of Hialeah, a copy of which is attached hereto and made a part hereof as Exhibit "1", and further authorizes the Mayor or his designee on behalf of the City to execute all other necessary documents in furtherance thereof. All action taken to date by officers of the City in furtherance of the acceptance of the grant award and performance of this agreement is hereby approved, confirmed and ratified.




