

ORDINANCE NO. 2016-79

ORDINANCE OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA AMENDING HIALEAH, FLA. ORDINANCE 2015-56 (SEPT. 24, 2015) ADOPTING THE CAPITAL PROJECTS FUND BUDGET FOR FISCAL YEAR 2015-2016, TO APPROVE AND RATIFY SUPPLEMENTAL APPROPRIATIONS IN THE AMOUNT OF \$841,702 FOR A NEW YEAR-END CAPITAL PROJECTS FUND BUDGET IN THE TOTAL AMOUNT OF \$3,130,328; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING FOR A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, at year-end the City received approximately \$841,702 in additional revenues in excess of the budgeted amount; and

WHEREAS, expenditures exceeded budgeted appropriations by an estimated amount of \$841,702; and

WHEREAS, this revenue was appropriated during fiscal year 2015-2016 in the manner set forth in the schedule attached as "Exhibit A"; and

WHEREAS, pursuant to Florida Statutes Section 166.241(4), the governing body of a municipality may amend a budget within sixty days following the end of the fiscal year; and

WHEREAS, the City now wishes to amend its fiscal year 2015-2016 capital projects fund budget accordingly.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

Section 1: Amendment of Hialeah, Ordinance 2015-56 (Sept. 24, 2015).

The Capital Projects Fund Budget for the City of Hialeah, Florida, for the Fiscal Year 2015-2016, approved and adopted by Hialeah, Fla. Ordinance No. 2015-56 (Sept. 24, 2015) is hereby amended by \$841,702 in supplemental appropriations for a new year-end total Capital Projects Fund Budget in an amount of \$3,130,328. All supplemental appropriations for Fiscal Year 2015-2016 are hereby approved, confirmed and ratified.

Section 2: Repeal of Ordinances in Conflict.

All ordinances or parts of ordinances in conflict herewith are hereby repealed to the extent of such conflict.

Section 3: Severability Clause.

If any phrase, clause, sentence, paragraph or section of this ordinance shall be declared invalid or unconstitutional by the judgment or decree of a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs or sections of this ordinance.

Section 4: Effective Date.






