

RESOLUTION NO. 2018-059

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA APPROVING A COMMUNITY ENHANCEMENT AREA BENEFIT PROGRAM FOR THE PURPOSE OF BEAUTIFICATION, ENHANCEMENT AND IMPROVEMENT OF PUBLIC FACILITY LOCATIONS, AND CULTURAL ENRICHMENT OF THE CITY OF HIALEAH COMMUNITY; FURTHER AUTHORIZING THE MAYOR TO ESTABLISH AN ARTS COMMITTEE CONSISTING OF THREE MEMBERS, TO SELECT THE ARTISTS WHO ARE GOING TO PARTICIPATE IN THE COMMUNITY ENHANCEMENT AREA BENEFIT PROGRAM; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Community Enhancement Area Benefit Program has been designed for the purpose of beautification, enhancement and improvement of public facility locations, and cultural enrichment of the City of Hialeah community;

WHEREAS, the Community Enhancement Area Benefit Program aims to celebrate the history and culture of Hialeah through the commission of uniquely painted sculptures to be permanently installed at various public facilities throughout the City;

WHEREAS, the final art pieces will be sculptures, each in the shape of a flamingo, a prominent symbol of the City of Hialeah, made of steel and fiberglass with approximate dimensions of 7 feet in height and 5 feet 5 inches in width; and

WHEREAS, the Mayor shall establish an arts committee, which shall evaluate the proposals or drafts submitted by eligible artists as a result of an "open call" issued by the City, and select the group of artists who will participate in the Community Enhancement Area Benefit Program by painting the sculptures.

NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA THAT:


Section 1: The foregoing facts and recitations contained in the preamble to this resolution are incorporated and adopted by reference as if fully set forth herein.

Section 2: The City of Hialeah hereby approves a Community Enhancement Area Benefit Program for the purpose of beautification, enhancement and improvement of public facility locations, and cultural enrichment of the City of Hialeah community, and further authorizes the Mayor to establish an arts committee consisting of three members, to select the artists who are going to participate in the Community Enhancement Area Benefit Program.

Section 3: This resolution shall become effective upon signature of the Mayor of the City of Hialeah, Florida or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.


