

**RESOLUTION NO. 2018-068**

RESOLUTION OF THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, AUTHORIZING THE CITY USE OF \$885,000 OF HOME INVESTMENT PARTNERSHIPS (HOME) PROGRAM FUNDS AWARDED TO THE CITY BY THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) FOR RENTAL HOUSING REHABILITATION OF A CITY-OWNED ELDERLY-OCCUPIED AFFORDABLE HOUSING BUILDING CONTAINING A TOTAL OF FIFTY-SEVEN (57) UNITS LOCATED AT 20 WEST 6 STREET, KNOWN AS THE VILLA AIDA; AND PROVIDING FOR AN EFFECTIVE DATE.

**WHEREAS**, the City of Hialeah is an entitlement community and receives an annual allocation of funds from the United States Department of Housing and Urban Development (HUD) under the Community Planning and Development (CPD) Entitlement programs, including the HOME Investment Partnerships (HOME) Program; and

**WHEREAS**, the City of Hialeah wishes to utilize \$885,000 in HOME Program funds awarded to the City by U.S. HUD to fund a rental housing rehabilitation project, an eligible HOME Program activity pursuant to the U.S. Code of Federal Regulations Title 24 Part 92, for the renovation of a city-owned elderly-occupied affordable housing property, in accordance with the budget attached hereto and made a part hereof as Exhibit 1; and

**WHEREAS**, the elderly housing property known as Villa Aida and proposed to be rehabilitated with the HUD-awarded funds is located at 20 West 6<sup>th</sup> Street and contains fifty-seven (57) units of; and

**WHEREAS**, Villa Aida was constructed in 1997 and is in need of rehabilitation; and

**WHEREAS**, the rental housing rehabilitation project proposes to update the building's windows and doors to increase energy efficiency and improve the buildings to withstand windstorms at a standard that satisfies current technical codes; and

**WHEREAS**, the City finds the use of HOME Program funds pursuant to the federally mandated regulations provided in U.S. 24 CFR 92 for rehabilitation of the elderly housing building to be beneficial to the safety and welfare of all current and future residents of the Villa Aida rental housing community.


NOW, THEREFORE, BE IT RESOLVED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF HIALEAH, FLORIDA, THAT:

**Section 1:** The foregoing facts and recitations contained in the preamble to this resolution are hereby adopted and incorporated by reference as if fully set forth herein.


**Section 2:** The City of Hialeah, Florida hereby authorizes the use of HOME Investment Partnerships (HOME) Program grant funds awarded by the U.S. Department of Housing and Urban Development (HUD) in the amount of \$885,000.00, in accordance with the budget attached hereto and made a part hereof as Exhibit 1, for the rental housing rehabilitation of a city-owned elderly housing building located at 20 West 6<sup>th</sup> Street, known as Villa Aida.

**Section 3:** This resolution shall become effective when passed by the City Council and signed by the Mayor or at the next regularly scheduled City Council meeting, if the Mayor's signature is withheld or if the City Council overrides the Mayor's veto.


